Appendix A, A-4 Mandatory Technical Requirements

Failure to satisfy all the Mandatory Technical Requirements listed below within **two (2)** business days of the Region's request will, subject to the express and implied rights of the Region, be cause for disqualification and the response will not be evaluated further.

1. All Bidders must provide a copy of the following:

- (i) Environmental Compliance Approvals (ECA issued by the Ministry of Environment, Conservation and Parks (MOECP) for the Province of Ontario) for the following:
 - operation of a licensed Organics Processing Facility within the Province of Ontario as defined within;

If a separate transfer station is not being proposed, the ECA must also confirm that the licensed Organics Processing Facility is within the boundaries of the Region of Durham.

Further to this, for the portion of work within the City of Oshawa and the Town of Whitby, the ECA must also confirm that the licensed Organics Processing Facility is located within the boundaries of the City of Oshawa or Town of Whitby.

- (ii) A letter of surety from their financial institution confirming that the Bidder would be able to qualify for the issuance of an irrevocable Letter of Credit in the amount of at least \$500,000.00 should they be the successful bidder on the subsequent RFT.
- 2. If your proposed solution includes a Transfer Station that is separate from the Organics Processing Facility, Bidders must provide the following:
- (i) A copy of the Respondent's Provincial Commercial Vehicle Operators Registration
 (CVOR) demonstrating a rating of 'satisfactory' or greater. If the Respondent intends to subcontract the haulage portion of the Contract, the CVOR of the

subcontractor must be provided. Any CVOR with a rating less than "satisfactory" shall deem the submission as non-compliant and will not be considered further;

- (ii) A copy of the Environmental compliance Approvals (ECA issued by the Ministry of Environment Conservation and Parks (MOECP) for the Province of Ontario) for:
 - operation of a licensed transfer station for the receipt and acceptance of SSO materials
 - confirmation that the location of the transfer station is within the boundaries of the Region of Durham

Further to this, for the portion of work within the City of Oshawa and the Town of Whitby, the ECA must also confirm that the transfer station is located within the boundaries of the City of Oshawa or Town of Whitby.

- 3. If your proposed Organics Processing Facility (within the Province of Ontario) is processing SSO using Anaerobic Digestion, Bidders must provide the following:
- (i) A copy of the Environmental compliance Approvals (ECA issued by the Ministry of Environment Conservation and Parks (MOECP) for the Province of Ontario) for:
 - sewage discharge issued under the Ontario Water Resources Act (OWRA)

Appendix A, A-6 Rated Criteria

Respondents who receive 20 points or higher in this category, but do not receive a combined total threshold score of seventy (70) points overall will not proceed to the next stage of the evaluation process.
