1 The Regional Land Division Committee (LDC) was created by Regional Council on December 19, 1973 to make independent decisions on the disposition of consent applications (e.g. severance, right-of-way, lot line adjustment) that have been submitted to the Region for approval under the Planning Act. The Committee consists of eight lay-citizen members (one representing each area municipality), that are appointed by council for a four-year term. The current Chair is Gerri Lynn O'Connor, the Township of Uxbridge's representative. The LDC meets monthly and considers approximately 150 consent applications per year.

THAT the Tourism, Heritage and Community Programs Committee receive Report RC-07/19 of Amanda Ferraro, Director of Community Services for information;

AND THAT the following resolution be endorsed by the Township of Uxbridge:

WHEREAS Sport Durham is seeking approval by Regional Council to submit a bid to host the 2022 Ontario Summer Games in the Durham Region;


support; and acknowledge that if the Region is awarded the bid, the Township of Uxbridge is a willing host and participant in the games;

Please be advised that the following resolution was endorsed by Ajax Town Council at its Meeting held on May 21, 2019:

WHEREAS the Government of Ontario is undertaking a Regional Government Review to examine governance, decision-making, and service delivery functions of Ontario's 8 regional municipalities, Simcoe County, and all respective lower-tier municipalities;

AND WHEREAS the Regional Municipality of Durham ("the Region") and its 8 lower-tier municipalities continue to be leaders and advocates for good governance in the municipal sector, as is evidenced by the Region's decision to engage voluntarily in the 2015 Regional Council Composition Review, and the decision of Durham voters to elect the position of Regional Chair as of 2014;

AND WHEREAS there is a strong and proven relationship between the Region and its lower-tier municipalities in Durham, and the double-direct voting system ensures that members of both local and regional councils are well informed about all issues and concerns impacting residents;

AND WHEREAS Ajax Council ("the Town") agrees that there are opportunities for transfer of services and/or better service alignment between the Town and the Region to increase efficiencies for residents and businesses;

AND WHEREAS Ajax Council is confident that, through the Regional Government Review, the Province of Ontario will respect municipal autonomy, identity and representation;

NOW THEREFORE BE IT RESOLVED THAT Ajax Council supports a continued two-tier municipal structure and double-direct voting system and governance model throughout Durham Region, noting that the Town is open to improving the alignment of services between the upper- and lower-tiers in order to achieve increased efficiencies;

AND THAT this resolution be distributed to all Durham Region municipalities, the Region of Durham, the Regional Government Review Advisors, Minister Steve Clark, MPP Rod Phillips, and all Durham Region MPPs.

Whereas the Regional Governance Review Terms of Reference for Special Advisors Michael Fenn and Ken Seiling states that all materials produced by the Special Advisors, including research analysis, reports and recommendations, are the exclusive property of the Ministry of Municipal Affairs and Housing and may be released publicly at the discretion of the Ministry;

Whereas the Regional Governance Review must be transparent in the interest of accountability and in consideration of the potential impacts to local and regional municipal governments;

Whereas the Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO) has requested that the report containing the Special Advisors findings and recommendations to the Minister of Municipal Affairs and Housing that is due to be presented in early July be made public;

Please be advised that at the last regular Council meeting of the Township of Scugog held June 24, 2019 the above captioned matter was discussed and I wish to advise that the following resolution was passed:

**“WHEREAS** in January of 1999, GO Transit established a route to Port Perry;

**WHEREAS** this established route provides an essential service to residents accessing downtown Toronto as commuters, residents seeking specialized health care, education or other business and recreational needs not provided locally;

**WHEREAS** GO Transit are eliminating the 81a bus route from Port Perry to Whitby Brock Street Lake Shore East GO station;

**WHEREAS** the service changes will render bus routes 81 and 81a ineffective by reducing weekday service by 78% and weekend service by 50%;

**WHEREAS** GO Transit is the only bus servicing the Port Perry to Whitby Corridor and bus route 81a represents the majority of trips on this route;

**Endorsement of LUMCO Resolution regarding Retail Cannabis Stores**

- A. THAT the Association of Municipalities of Ontario (AMO) and the Premier of Ontario be advised that Brantford City Council ENDORSES the following Resolution adopted by LUMCO (Large Urban Mayors Caucus of Ontario) at its May 24, 2019 Meeting:

WHEREAS in April 2017, the Federal Government introduced Bill C-45, The Cannabis Act, and Bill C-46, An Act to Amend the Criminal Code, outlining plans to legalize, regulate and restrict access to cannabis in Canada; and

WHEREAS the Province of Ontario responded with corresponding legislation, the Cannabis Control Act, 2017, the Ontario Cannabis Retail Corporation Act, 2017, the Cannabis License Act, 2018, and Bill 36- Cannabis Statute Law Amendment Act, 2018; and

WHEREAS collectively, this legislation created a regulatory regime effective October 17, 2018 that allows Ontario residents who are 19 years of age or older to: 1. Purchase recreational cannabis online through the Ontario Cannabis Store 2. Possess up to 30 grams of cannabis 3. Grow up to four (4) cannabis plants per household 4. Purchase cannabis from a provincially approved private retail supplier as of April 1, 2019; and

WHEREAS municipalities across Ontario were given until January 22, 2019 to choose if retail cannabis stores will be prohibited within their borders and those that "opted out" may at a later date by resolution of their respective Council, lift the prohibition and permit them in the future; and



WHEREAS Ontario Regulation 468/18 permits limited municipal regulatory control over location and zoning, licensing and spatial separation to sensitive land uses other than a school as defined by the Education Act;

NOW THEREFORE BE IT RESOLVED THAT the Large Urban Mayors Caucus of Ontario (LUMCO) recommends that additional local regulatory controls be approved by the Province of Ontario around retail cannabis stores that would: A. Provide a municipality with the unrestricted ability to control the location of retail cannabis stores through zoning; and, B. In the alternative to A; 1) Limit the concentration and number of cannabis retail stores in any one municipality by introducing a minimum distance separation measure between retail stores (minimum 500 metres); and, 2) That cannabis stores be restricted to a Commercial Zone or Area which permits retail stores; and 3) Clearly defining sensitive land uses, in addition to schools, which would be impacted by having a retail cannabis store located adjacent to them. Such other sensitive land uses would include, but not be limited to, day cares, colleges and universities, community centres, nursing homes, libraries and actively programmed municipal parks; and, 4) That the current minimum distance separation of 150 meters from a cannabis retail store to a school be increased to a minimum of 500 metres from any sensitive land use to be defined as noted in paragraph 3 above; and C. That all municipalities that have approved retail cannabis stores to be located in their jurisdictions receive 50% of ALL excise tax collected by the Province of Ontario on the sale of cannabis; not limited to revenues in excess of \$100 million; and

THAT upon adoption of this Resolution by LUMCO, it be presented to all Ontario Municipal Councils with a request to endorse and that the municipally adopted resolutions then be forwarded to the Association of Municipalities of Ontario (AMO) and the Premier of Ontario's office;

Further, THAT members of the LUMCO Retail Cannabis Committee request a meeting with Minister Doug Downey regarding this resolution and to also request the AMO Board add this topic as an agenda item for discussion at the August 2019 AMO Annual Conference.

### **New Employment Services Prototype Regions Announced**

Today the Ministry of Training, Colleges and Universities (MTCU) [announced](#) the three regions where Ontario will prototype its new service delivery model for employment and training services as part of Social Assistance Reform. The new model will see employment-related functions of Ontario Works and the Ontario Disability Support Program integrate with Employment Ontario into a single employment and training services system.

The new employment regions of Peel Region, Muskoka-Kawarthas and Hamilton-Niagara will transition to the new approach by fall 2019. A full provincial roll out will begin in 2022.

The Muskoka-Kawarthas region includes the District of Muskoka, the City of Kawartha Lakes, the County of Haliburton, the County of Peterborough, the City of Peterborough and Northumberland County. The Hamilton-Niagara region covers Hamilton, Brant County, Brantford, Norfolk County and Niagara Region. The Ministry of Children, Community and Social Services (MCCSS) and MTCU sent out a joint letter to all Consolidated Municipal Service Managers (CMSMs) and District Social Service Administration Boards (DSSABs) earlier today with information.

Organizations interested in serving as the employment service system manager in one of the three prototype regions will have to apply to a competitive process in the [Ontario Tenders Portal](#). The deadline for Request for Qualifications submissions is July 23, 2019. A call for proposals will then follow. While municipal governments are eligible to apply, they do not have a right of first refusal and will need to compete with other interested organizations in the area.



AMO is actively monitoring Ontario's employment services initiative and the roll-out of the prototypes. We will work with the province and municipal governments to mitigate any negative municipal impacts in the transition to the new model, including in prototype regions and beyond.

Throughout the consultations, AMO has raised concerns about the fiscal, programmatic, accountability and labour relations impacts of this transition for municipal governments. There needs to be a seamless transition for clients regardless of who is chosen as the employment service system manager in a given region. The successful proponents must demonstrate an ability to serve vulnerable residents, including those who are far from entering the labour market and in need of additional supports.

This activity is in addition to other provincial announcements that may result in significant restructuring and labour relations challenges for municipal governments, including on public health and land ambulance. Ontario needs to be cognizant of the cumulative impacts of these provincial changes on municipal governments, local residents and the property tax base.
