# Health Equity Series – Improve Health Through Financial Empowerment #2

Health Care Providers have a unique opportunity to address the social determinants of health during client interactions. Health status improves at each level of the income hierarchy.

According to Prosper Canada, Financial Empowerment is an upstream poverty reduction approach focused on improving the financial security of residents living with low income through interventions aimed at building financial literacy, enhancing access to income supports and benefits, growing savings, reducing barriers within the financial system, and more. ## **Canada Learning Bond**

Eligible families in Durham Region can receive up to \$2,000 from the Government of Canada deposited into a Registered Education Savings Plan (RESP) for their child to save for post-secondary school. They do not need to put any of their own money into the RESP to get the benefit.

To qualify for the Canada Learning Bond:

- The child must be born in 2004 or later.
- The child must be a resident of Canada.
- The net family income must be modest. A modest net family income is up to \$53,359 for families with one to three children. Any year of a modest income may meet the criteria.
- Qualifying details are found at Canada.ca/canada-learning-bond.

#### Did you know?

**Lower educational attainment is linked to poorer health and social outcomes**, such as higher prevalence of working poverty, household food insecurity, and chronic diseases. Almost one-third (29%) of Durham residents have no higher education beyond a high school diploma or equivalent.

**Even small amounts of education savings can have a big impact.** Children with education savings of up to \$500 are three times more likely to enroll in post-secondary and four times more like to graduate.

**More than one-half of eligible children in Durham are not receiving Canada Learning Bond.** Only 45% of children who are eligible locally are beneficiaries of the Canada Learning Bond.

#### Tell clients how to access the Canada Learning Bond if unable to attend a sign-up event:

- Social Insurance Numbers (SINs) are required for both the parent/caregiver and the child. Information about applying for SINs can be found on: <u>canada.ca/social-insurance-number</u>.
- Contact a bank or financial organization that offers RESPs and book an appointment to open a no-fee RESP and get the Canada Learning Bond.

# Canada Learning Bond sign-up event

Eligible families can receive up to \$2,000 for their child's post-secondary education from the Government of Canada.

To qualify for the Canada Learning Bond:

- The child must be born in 2004 or after.
- The child must be a resident of Canada.
- The adjusted family income must be modest (a modest adjusted family income is up to \$53,359 for families with one to three children).

#### **Canada Learning Bond sign-up event information**

To open a Registered Education Savings Plan (RESP) and sign up for a Canada Learning Bond at the clinic, please **bring Social Insurance Numbers (SIN) and valid identifications (ID) for both the parent/guardian/caregiver and child**. Valid ID can include photo ID for the parent/guardian/caregiver (excluding health cards) and a birth certificate for the child.

Service Canada will be on site to issue SINs to those who need them. To be issued a SIN, please bring a primary identity document (e.g., Birth Certificate, Certificate of Canadian Citizenship, etc.) and a secondary identity document (e.g., a passport, or provincial or territorial identification).
