Report:

1. Purpose

1.1 The purpose of this report is to meet the legislated requirements under section 12.1(3) of the Municipal Elections Act, 1996 and report to Council, within 90 days after voting day, about the identification, removal and prevention of barriers that affect electors and candidates with disabilities.

2. Background

- 2.1 On April 6, 2018 the 2018 Municipal Election Accessibility Plan was presented to Regional Council through Report #2018-INFO-50. The Plan largely built off the Region's 2016 – 2021 Multi-Year Accessibility Plan and the Corporate Accessibility Policy, both of which seek to ensure equal participation for persons with disabilities, including candidates and electors.
- 2.2 The Plan identified potential accessibility considerations for both candidates and electors while attending Regional Headquarters, attending candidate information sessions, or accessing information via durham.ca or by telephone.
- 2.3 As part of the Plan, the Regional Clerk solicited feedback on the manner in which services were provided to persons with disabilities during the Election process.

3. Discussion

3.1 During the election period Corporate Services – Legislative Services staff received a number of inquiries and had numerous interactions with candidates and electors, in -person, online and via phone. Voting day was on October 22, 2018 and a small number of electors along with members of the media, attended Regional Headquarters to view the results for the Office of Regional Chair. 3.2 During the election period and following voting day, no feedback was received on the services provided to persons with disabilities during the Election process.

4. Conclusion

- 4.1 While the role of the Region in the municipal election process is somewhat limited, the Region will continue to strive to provide barrier-free access to ensure that persons of all abilities are able to participate in the municipal election process.
- 4.2 Going forward, should any feedback be received on the manner in which services were provided to persons with disabilities during the Election process, it will be taken into consideration for the 2022 municipal election.

Please be advised that at its regular meeting held, Monday October 1, 2018 the Council of the Township of McKellar passed the following resolution:

18-317 WHEREAS on September 17, 2018 the following statement was issued from the AMO Office of the President "We urge the Ontario government to clearly state its interests in having governance review, and how it will proceed. And we urge the Ontario government to work with AMO and the municipal order of government to change requirements that undermine municipal finance, infrastructure investment and efficient service delivery all across Ontario" as per the attached letter;

AND WHEREAS the current President of AMO is the Mayor of Parry Sound;

AND WHEREAS the goals for a "Governance Review" may not be the same for the Town of Parry Sound as they are for other municipalities in the District of Parry Sound;

AND WHEREAS AMO has no mandate from the District of Parry Sound Municipalities to speak on their behalf on governance models such as Regional Government or Amalgamations;

AND WHEREAS the Honourable Steve Clark, Minister of Municipal Affairs and Housing sent out the attached letter indicating there will be discussion with municipal partners regarding governance models;

NOW THEREFORE BE IT RESOLVED that the Township of McKellar requests that any discussions that AMO has with the Province be preceded with an open meeting between AMO, all members of Council and members of the public to determine the desires of each municipality in regard to governance models; AND FURTHERMORE BE IT RESOLVED that our MPP Norm Miller and the Province of Ontario also have an open dialogue with the Township of McKellar and respect the opinions of the township as it regards to any review of the local governance model.

Two Municipal Class Environmental Assessments (MCEAs) are occurring within close proximity of one another within the Town of Whitby. Brookfield Residential, in partnership with the Regional Municipality of Durham (Region), is undertaking an MCEA study to address the rehabilitation of the Pringle Creek Bridge. The Town of Whitby, in partnership with the Region, is also undertaking a separate MCEA to investigate modifications to Brock Street South and Water Street.

Both studies are following the 'Schedule C' MCEA process, under the Provincial Environmental Assessment Act. The Pringle Creek Bridge study is currently in Phase 3 of the MCEA process, which involves the evaluation of the alternative designs for the replacement of the bridge structure. The Brock Street and Water Street study is beginning Phase 1 of the MCEA process in which the existing problems and potential opportunities will be identified.

Although the two studies are independent of each other, to best facilitate local residents and public discussion, public consultation events for both projects will be held at the same time. The event scheduling information is provided below:


Brookfield Residential, in partnership with the Regional Municipality of Durham, is undertaking a Schedule 'C' Environmental Assessment (EA) study to address improvements to the Brock Street South (Reg. Rd. 46) bridge over Pringle Creek, which is located approximately 700 m south of Victoria Street (Reg. Rd. 22) in the Town of Whitby. The existing bridge, constructed in 1962, requires rehabilitation and is subject to potential

flooding across adjacent lands due to the limited width of the creek under the bridge. The Study will also include consideration of existing and future traffic needs for the area, and improvements for better pedestrian, cycling and Waterfront Trail connections.

Brookfield Residential is undertaking this study as part of the preparation for development of its lands located east and west of Brock Street, south of the bridge. As the owner of the bridge, the Regional Municipality of Durham will be involved throughout the study, including reviewing and approving the resulting recommendations.

This Study is being conducted in accordance with the planning and design process for Schedule 'C' projects, as outlined in the Municipal Class Environmental Assessment process (Municipal Engineers Association, October 2000, as amended in 2007, 2011 and 2015), which is approved under the Ontario Environmental Assessment Act.

Brookfield Residential is hosting the second Public Information Centre (PIC #2) to share the results of the evaluation of the alternative design concepts and identify the preferred design for the Pringle Creek Bridge. Brookfield invites all interested parties to attend the second PIC on



Monday, November 19, 2018 from 5 to 8 p.m. at the Port Whitby Marina Avalon Lounge located at 301 Watson Street West. The format of this PIC will follow an "open house" style event where attendees can dropin between the hours specified above to speak with representatives from the Study Team who will be present to answer questions and discuss any Project comments or concerns. This PIC will be combined with PIC #1 for the Class EA Study of Modifications to Brock Street and Water Street, which will provide a broader view of planned works in the area. Municipal Class Environmental Assessment Study – Road Modifications to Brock Street South and Water Street




Figure 1: Study Area

The Town of Whitby and the Regional Municipality of Durham (Region) are undertaking a Municipal Class Environmental Assessment Study (this Study) to investigate road modifications to **Brock Street South/Regional Road 46** (from Victoria Street to Front Street; and from south of the existing Pringle Creek Bridge to Water Street) and **Water Street** (from Brock Street South to South Blair Street). Please see Figure 1 for the study area.

This Study is being conducted in accordance with the planning and design process for a Schedule 'C' Municipal Class Environmental Assessment under the Ontario Environmental Assessment Act. This Study will define the problem, identify and evaluate alternative solutions to the problem, evaluate alternative design concepts for the preferred solution, and recommend a preferred design concept. The recommended road modification work will address road alignment and drainage issues, facilitate future land use, and accommodate future traffic demand and active transportation needs. A total of three Community Open Houses (COH's) will be held to present this Study.

This COH is intended to introduce the Study and to obtain initial input from the public and stakeholders. 
