Report:

1. Purpose

1.1 This report responds to an enquiry from a previous Committee of the Whole meeting at which a question was asked about whether staff track job loss vacancies, in particular the retail sector.

2. Background

- 2.1 Each of the area municipal economic development offices was contacted to determine their process for tracking business closures and job losses.
- 2.2 Across the region, the local economic development offices do not specifically track job losses as an on-going process; however, if it is a significant closure or job loss in retail and other sectors, tracking does occur, such as the closure of Target stores.
- 2.3 The Business Count database, produced through the annual Business Count program, contains information about businesses that have closed each year. The data includes sector and the number of jobs. The number of business closures and job losses are collected, but not specifically reported through the Business Count program. However, the information is available for research purposes.

At the April 11, 2018 public meeting for the proposed Regional Development Charge By-law and the related underlying background study, Council requested clarification of the intent and potential impacts of the one proposed revision to the Regional Well Interference Policy, specifically section 1.0 (b) of Attachment No. 1 of Appendix C, which states:

1. Well Interference During Construction Provisions

b) In the event that the resident is unwilling to cooperate with the Region's investigation into the well interference claim, as determined by the Commissioner of Works, the "During Construction Provisions" of the well interference policy will no longer be available to provide relief to the subject property."

The proposed change is being requested because the Region requires cooperation from the resident to review the magnitude and, in particular, the duration of the well interference.

When a property owner's private well is impacted by the construction of Regional services, the Region continues to monitor the existing well while a temporary solution is implemented (typically a temporary water supply tank and regular potable water delivery). If the Region determines that the well has sufficiently recovered, the temporary solution is no longer provided.

There have been instances where residents prefer the temporary water supply as it is often a better water supply than their existing, marginally performing well and it is provided at no cost to them. There has been an occurrence where the resident has refused to allow the Region access to their property and has removed monitoring equipment which prevented the Region from determining if the well has recovered sufficiently. The impacts of these actions by the landowner are additional temporary water supply costs as well as significant additional Regional staff time in trying to resolve the issue.

The vast majority of residents work cooperatively with the Region through this process. This proposed revision to the Regional Well Interference Policy will have no impact on those residents.

He noted another feature of the Durham Transit website in order to help customers plan their travels is Triplinx where you would enter a start and end location and it will provide the best route.

B. Holmes advised of updates coming to Specialized Services that include Specialized Services Restraint Policy; Support Person Card; Eligibility Review Process; WEBPass Updated 2018; and Trip Planner for customers using family services (integrated) 2018.

B. Holmes responded to questions with regards to new individuals to Durham Region and how they can identify what stop they are at or what the bus number is; current issues with the Durham Transit website and what is being done in 2018 to improve it; the AODA legislation requiring new sites to be compliant to the Web Content Accessibility Guidelines (WCAG) 2.0 Level A or AA; the cost comparison of the on-demand service or an additional bus route; and limits to specialized services.
