Report:

1. Purpose

1.1 To advise Council of the upcoming test to Durham Region's nuclear public alerting system.

2. Background

- 2.1 As a designated municipality under the Provincial Nuclear Emergency Response Plan (PNERP, 2017), Durham Region is required to update and test the nuclear public alerting system as part of its regular maintenance program and to raise public awareness.
- 2.2 This year's test will be different than previous ones, as scheduled maintenance is required. As each siren is updated, it will quickly be tested. In total, 34 short, five-second siren alerts will sound, rather than a single one-minute test of all sirens simultaneously.
- 2.3 Durham Region's test will take place over five days:
 - a. On Monday, June 5th, landline phones in Durham Region within ten kilometers of the Darlington and Pickering Nuclear Generating Stations will receive an automated phone message. The message will advise that it is a test and will provide notice that the sirens will be tested during the week within three kilometers of the Darlington and Pickering Nuclear Generating Stations.

- b. From Monday, June 5th to Friday, June 9th, thirty-four sirens located within three kilometers of the Darlington and Pickering Nuclear Generating Stations will be sounded individually for approximately five seconds after the required updated has been completed.
- 2.4 Messages will be posted to the Region's social media accounts confirming when the tests have commenced and when they have been completed.
- 2.5 To increase public awareness, Durham Region has developed a comprehensive communications plan to let residents, businesses and other community stakeholders know about the test and this year's changes. The communications campaign will include, but is not limited to, the following:
 - a. Social media
 - b. Mobile signs
 - c. Advertisements for radio, print and online newspapers.
 - d. Our partners, the Local Area Municipalities, Toronto Office of Emergency Management and Ontario Power Generation, will help share our messages
 - e. Collaboration with Boards of Trade and Chambers of Commerce to help notify businesses in Durham Region.

1. Purpose

1.1 The purpose of this report is to inform Regional Council of the confirmation of the Region's Triple "A" Credit Rating by Moody's Investors Service.

2. Background

- 2.1 On January 31, 2023, Regional staff met with representatives of Moody's Investors Service (Moody's) to review the credit fundamentals of the Regional Municipality of Durham and their impact on the Region's Triple "A" credit rating. The presentation included the approved 2023-2032 water supply and sanitary sewer capital and debt forecasts. After the presentation, Regional Finance staff provided the updated capital and debt forecasts from the 2023 Regional Property Tax Business Plans as approved by Regional Council.
- 2.2 The 2023 water and sewer and property tax budgets reflected an increase of \$1.57 billion in capital and \$400 million in debt over 2023 to 2032 based on the 2022 forecast. The Region is moving into a significant infrastructure construction phase (64 per cent of the forecast debt is related to water and sewer infrastructure and seven per cent is related to transit electrification).
- 2.3 Moody's affirmed the Region's Triple "A" credit rating with a stable outlook in a report released on April 13, 2023. According to Moody's, Durham's Triple "A" credit strengths continue to reflect Durham's exceptional liquidity and low debt levels, strong population growth, economic diversity, and a positive operating profile with conservative fiscal and debt management. Durham Region is one of eight municipalities in Canada currently maintaining a Triple "A" credit rating with

stable outlook by Moody's.

3. Highlights of Durham's Major Credit Strengths

3.1 Moody's continues to recognize that Durham's relatively low debt levels, exceptional liquidity profile and strong operating balances provide financial flexibility to address the challenges of an expanding capital program and unanticipated expenditures:

"The rating outlook is stable, reflecting our view that exceptional levels of cash and investments and continued low debt levels will help absorb fiscal challenges relating to slower economic growth and rising capital spending."

"Durham also benefits from additional financial flexibility due to very low current levels of debt as a result of a multi-year effort to fund capital projects through pay-as-you-go financing instead of issuing public debt."

"The region maintains financial flexibility from a substantial liquidity cushion given exceptional levels of cash and investments, including reserves."

"While the majority of reserves are earmarked for specific purposes, these levels provide significant debenture holder security and are at the high end relative to Aaa-rated municipal peers."

- 3.2 Moody's continues to recognize Durham's strong population and economic growth and diversified economy as major credit strength. Program challenges associated with population growth can be addressed by the Region through its adherence to multi-year financial planning:

"Durham's credit profile is supported by an affluent tax base and strong long-term growth from a diversified economy, which leads to high levels of wealth and high tax- and rate-supported revenues. The economy has diversified over the last two decades as a decline in manufacturing has been offset by growth of other sectors including retail and wholesale trade, finance and professional services, education, health and social services. Durham has historically outperformed Ontario on several economic and labor market indicators, with favourable employment statistics, strong GDP growth and high GDP per capita."

3.4 Moody's also assesses Environmental, Social and Governance (ESG) Issuer Profile (IPS) and Credit Impact Scores (CIS) for municipally rated entities. The scores are part of Moody's ongoing commitment to demonstrate the systematic and transparent incorporation of material ESG issues into credit ratings:

"The Region of Durham's ESG Credit Impact Score is neutral-to-low (**CIS-2**) reflecting neutral-to-low exposure to environmental and social risks and a positive governance profile."

3.5 Moody's provides caution with respect to Durham's credit profile, which is pressured by population growth, elevated infrastructure spending to accommodate that growth and provincial funding changes that may lead to higher expenditures:

"A significant decline in liquidity levels that coincides with a rising debt burden and interest burden, or a sustained period of economic contraction leading to deficits would put downward pressure on the region's rating."

"Concurrently, the region's continued need to fund growth and maintenance infrastructure will retain pressure on capital spending and on securing funding. Continued population growth over the next decade – supported by rising federal immigration targets - will be a key driver of infrastructure spending in the coming decade."

4. Conclusion

- 4.1 Maintaining a Triple "A" credit rating is an important achievement for the Region. This accreditation reflects Regional Council's position to uphold key ratings factors as determined by Moody's, including conservative fiscal management, very strong budgetary performance, and low and manageable debt burden.
- 4.2 The Region's exemplary fiscal results are achieved and maintained through Regional Council's long-standing commitment to long-term financial planning. The disciplined approach to long-term financial planning are guided by the principles of fiscal sustainability, financial flexibility and taxpayer affordability. These principles assist the Region in retaining financial flexibility to maintain adequate funding for risk mitigation, unforeseen expenditures and maintain manageable property tax and revenue-based rate increases.
- 4.3 The Region's Business Planning and Budget process will reflect the continued support of the credit principles that are fundamental to the Region's Triple "A" credit rating.

Boards of health are required to "superintend, provide or ensure the provision of the health programs and services required by the [Health Protection and Promotion] Act and the regulations to the persons who reside in the health unit served by the board" (section 4, clause a, HPPA). In addition, medical officers of health are required to "[report] directly to the board of health on issues relating to public health concerns and to public health programs and services under this or any other Act" (sub-section 67.(1), HPPA).

Accordingly, the Health Information Update is a component of the Health Department's 'Accountability Framework', which also may include Annual Services Plans, Quality Enhancement Plans, Health Plans, Health Check-Ups!, program and other reports, business plans and budgets; provincial performance indicators and targets, compliance audits, inspections and assessments; RDPS certification; and accreditation by Accreditation Canada.

WHEREAS the Municipal Elections Act specifies that these documents are not protected by the Municipal Freedom of Information and Protection of Privacy Act, and requires the municipal clerk to make Form 4 available on a website and;

WHEREAS there has been concern expressed about those who hold public office and those who support them that they have been the subject of unnecessary attention and excessive scrutiny and;

WHEREAS the requirement to publish the personal home address of donors to specific candidates may discourage individuals from engaging in the democratic process to elect municipal and school board politicians;

THEREFORE, BE RESOVLED THAT the Council of the Municipality of Wawa calls on the Minister of Municipal Affairs and Housing for the Province of Ontario to protect the privacy of candidates and donors by removing the requirement for their street name, number and postal code to be listed on publicly available forms and;
