Early Learning Updates – General Updates

Serious Occurrence Reporting

With enhanced Ministry Serious Occurrence (SO) reporting requirements, and an increase in testing reported, the Children's Services Division (CSD) has updated our SO reporting process in order to reduce the administrative burden to Operators.

To clarify, as of September 30 only serious occurrences that are CONFIRMED positive COVID-19 cases need to be reported to the CSD.

Operators are no longer required to report SUSPECTED cases of COVID-19 to Children's Services. Please note that the elimination of reporting only applies to suspected COVID-19 serious occurrence incidents and all other <u>Children's Services Serious Occurrence reporting requirements</u> must still be followed.

All existing Ministry of Education – Licensing, Serious Occurrence reporting requirements must continue to be followed.

Electronic Screening Tools and Guidance

The Ministry of Health released the <u>COVID 19 Screening Tool for Children in School and Child Care</u> on October 1, 2020. We are aware that this tool and the guidance released with it has led to confusion and parent inquiries for many of you. While the tool is intended to be used by parents to assess whether their child has any symptoms of COVID-19 and if they are able to attend child care, the use of this screening tool does not allow operators to meet the legislative requirements for recording screening results as set out in the Child Care and Early Years Act (2014) as well as requirements dictated by the Durham Region Health Department as to when a child may return to care.

We have created new guidance documents and updated the <u>sample screening tools and policies</u> on our website to help you adapt the tools that you are using to continue to meet screening documentation requirements as well as requirements dictated by Durham Region Public Health.

We recognize that your organization may be using a school board/child care centre/early years specific screening tool/application or one developed by local public health partners. We ask that you align the criteria in these tools/application with the attached COVID-19 Screening Tool for Children, Staff, and Essential Visitors in Durham Region Licensed Child Care.

We understand that some families may be confused and frustrated with the many changes that are taking place. It is encouraged to communicate clearly with families that screening protocols, policies and Durham Public Health Department requirements are in place to keep everyone safe with the safety of their children at the forefront and that some of your policies as well as the expectations set out by Durham Region Public Health may go above and beyond what is outlined in the Ministry of Health screening.
