Report:

1. Purpose

1.1 This report provides an update on the Ontario Sand and Gravel Association, formerly the Ontario Aggregate Resources Corporation (TOARC), Management of Abandoned Aggregate Properties (MAAP) Program. This report provides information on the 13 sites within Durham Region were rehabilitated between 2013 and 2015.

2. The MAAP Program

- 2.1 The MAAP Program was initiated in January 1990 when the former Pits and Quarries Act was replaced by the Aggregate Resources Act (ARA). Under the former Act, the responsibility for rehabilitation was not defined. As a result, there were numerous abandoned pits in Ontario in need of rehabilitation. The MAAP Program provides for rehabilitation of pits and quarries that were abandoned prior to the enactment of the Aggregate Resources Act on January 1, 1990.
- 2.2 At the outset, the Ministry of Natural Resources and Forestry (MNRF) undertook an inventory of site disturbances that were thought to be the result of aggregate extraction. That investigation identified over 6,500 sites that had the potential for

rehabilitation.

- 2.3 When the ARA came into effect, it imposed a \$0.005 per tonne licence fee payable to the program. At the initiation of the Program, \$400,000 to \$600,000 was made available on an annual basis. The fee now paid by aggregate producers has risen to \$0.115/tonne. In addition to the rehabilitation of abandoned pits and quarries, monies from the fund also supports research into new and creative approaches to rehabilitation.
- 2.4 The extent to which older sites have reverted to other uses has been the subject of a re-evaluation of the original inventory. To date, it has been determined that thousands of sites no longer require intervention through the MAAP program. Many landowners have utilized the sites in their disturbed condition for a variety of functions (e.g. storage of farm implements, removal of gravel for personal use, etc.) and are not interested in having the site rehabilitated. The net effect of this reevaluation process has resulted in approximately 4,489 files being removed from the active inventory.
- 2.5 The MAAP program aims to rehabilitate 30 sites annually. This objective is divided into a spring and fall work program, in a condensed geographic area. Counties and regions targeted for work are rotated on a semi-annual basis to ensure that different areas of the Province are considered for rehabilitation work on an equitable basis.
- 2.6 To date, approximately \$8,500,000 has been spent to reclaim and/or rehabilitate over 720 ha of land, on over 450 sites. The work has been completed at no cost to the landowner. The cost to rehabilitate the average site has been just over \$11,500/ha. Over \$1,300,000 has also been allocated to research.

3. Rehabilitation Sites in Durham

- 3.1 Over the three year period, from 2013 to 2015, 13 sites were rehabilitated in Durham, as follows:

 - Lot 21, Concession 4, Former Township of Cartwright (Kemp Pit) –
 rehabilitated to pasture (Attachment 1 Site No. DUR-CA-155);
 - d. Lot 9, Concession 9, Former Township of Cartwright (Coxworth Pit) –

- rehabilitated to meadow (Attachment 1 Site No. DUR-CA-165);
- e. Lot 8, Concession 10, Former Township of Cartwright (Piney Pit) rehabilitated to meadow (Attachment 1 Site No. DUR-CA-167);
- f. Lot 4, Concession 8, Former Township of Cartwright rehabilitated to agricultural uses (Attachment 1 – Site No. DUR-CA-443);
- g. Lot 10, Concession 8, Former Darlington Township (Halminen Pit) –
 rehabilitated to pasture (Attachment 1 Site No. DUR-DA-221);
- h. Lot 10, Concession 8, Former Darlington Township (Woodley Pit) rehabilitated to pasture (Attachment 1 Site No. DUR-DA-046);
- i. Lot 2, Concession 9, Town of Pickering (Guy Pit) rehabilitated to pasture (Attachment 1 Site No. DUR-PI-296);
- j. Lot 7, Concession 3, Former Reach Township (Senn Pitt) rehabilitated to agricultural uses (Attachment 1 – Site No. DUR-RE-325);
- k. Lot 26, Concession 3, Uxbridge Township rehabilitated to agricultural uses
 (Attachment 1 Site No. DUR-UX-389);
- I. Lot 37, Concession 5, Uxbridge Township (Swindells Pit) rehabilitated to agricultural uses (Attachment 1 Site No. DUR-UX-394); and
- m. Lot 30, Concession Road 5, Town of Whitby (Sisson Pit) rehabilitated to natural areas by stabilizing an eroded bank and creation of an access road (Attachment 1 – Site No. DUR-WH-432).

4. Conclusion

4.1 In the future, if the MAAP Program rehabilitates additional sites in Durham, Committee of the Whole will be advised accordingly.





Attachment1: **MAAP Program Rehabilitation Sites**

An update on Poverty Reduction efforts within the Social Services Department and details surrounding the additional \$100,000 allocated to the Health and Social Services Budget from Regional Council during the meeting held on February 17, 2016 to specifically address child poverty in Durham.

Report:

1. Purpose

1.1 The purpose of this report is to provide details surrounding the Poverty Reduction efforts undertaken within the Social Services Department and provide additional details specific to the \$100,000 allocated during 2016 to address child poverty in Durham.

2. Background

- 2.1 During the 2016 Budget deliberations, Regional Council allocated an additional \$100,000 to reduce poverty in Durham Region. Staff was directed to focus efforts on child poverty, particular but not exclusively in priority neighbourhoods.
- 2.2 Staff in the Social Services department approached this direction from Council by immediately working on the development of a Financial Empowerment Framework.
- 2.3 It was determined that the Framework will help to address the income inequalities

within poverty; understanding that poverty is often influenced from a structural and economic imbalance for the most vulnerable populations within our region. While not finalized, specific areas of effort were developed within the Framework and are detailed in this report.

3. Financial Empowerment Framework

- 3.1 The following directives, requests, information and considerations informed the development of the Framework:
 - a. Report #2016-GEN-05 dated April 17, 2016 highlighted the impacts of the 2016 Ontario Budget on Social Services. Highlights from the Ontario Budget that influenced the development of the Framework include;
 - The elimination of child support as a deduction from Ontario Works benefit cheques.
 - Ontario Student Assistance Program reform, resulting in free postsecondary tuition for families with an annual income of \$50,000 or less.
 - The Digital Government Action plan outlines the shift to digital service delivery including a Social Assistance Online pilot and testing of reloadable payment cards.
 - Social Assistance Reform focuses on ways to empower people to engage with government in ways that make sense for the user, not the delivery agent.
 - A commitment to a Basic Income Pilot initiative by the Province.
 - Benefits Transformation includes a commitment to broadening information sharing and modernizing privacy frameworks. The commitment to this area of work was reinforced by the August 4th 2016 announcement of the opening of the Office of Human Service Integration.
 - b. Correspondence between the City of Oshawa and the Commissioner of Social Service dated December 9, 2015 requesting that "pursuant to DS-15-211 that the Region of Durham take a lead role in the development of an Oshawa Community Development Plan and that the City of Oshawa staff participate in its development as a key stakeholder".
 - c. Direction Memo dated November 20, 2015 Motion Regarding a Future Youth Employment Strategy. (Councillor McQuaid-England).
 - d. The federal government collapsed six income benefits streams into one

- National Child Benefit with an anticipated 40% reduction of child poverty nationally.
- e. The Health Neighbourhoods Report, created by the Health Department, and subsequent communication shone a light on areas of need providing an opportunity for targeted efforts.
- f. The Provincial Poverty Reduction Strategy is funding pilot projects designed to reveal best practices. Results are pending.

4. Financial Empowerment Framework - Approach

- 4.1 There are ten (10) areas of effort outlined within the Framework. Consideration was given to balance areas of effort to realize both short and long-term financial impacts. The areas of effort outlined are primarily concentrated on efforts to assist low-income residents in accessing more income relatively quickly.
- 4.2 Schools of thought pertaining to poverty reduction generally agree and assert that when people living with low income have access to greater incomes, this income will be spent on improving the lives of their families. The framework builds on that assertion.
- 4.3 Developing a framework rather than a strategy allows for flexibility and responsiveness. If any one area of effort is proving to be unsuccessful, a framework allows for a quick assessment and realignment of resources.
- 4.4 Poverty reduction efforts have been underway for decades in Durham Region in a wide variety ways, delivered by a plethora of agencies, organizations, governments and faith communities. The Framework acknowledges the work of others and focuses on areas of effort generally within the purview of the Social Services Department and partners.
- 4.5 Each of the areas of effort will develop a data collection and evaluation plan in order to facilitate, within a reasonable time frame, an assessment of success.

5. Financial Empowerment - Areas of Effort

Many of the areas described have a direct impact on reducing child poverty.

5.1 Area of Effort #1: Banking

There are Durham residents who do not have bank accounts, precluding them from participating in cost effective on-line banking, direct deposit of and access to benefits and reduced administrative fees. Landlords, schools, utilities and employers expect a person to have a bank account. A bank account is an element of financial and social inclusion.

- a. Ontario Works offices in Durham currently offer assistance with opening bank accounts.
- b. This area of effort is considered a best practice and is in alignment with the Provinces Digital Government Action Plan.

5.2 Area of Effort #2: Tax Filing

There are Durham residents who do not file income tax returns. There are Federal and Provincial subsidies, benefits and rebates available only via tax filing. These rebates have been proven to improve income. Tax filing is an element of financial inclusion.

- a. Ontario Works offices in Durham currently offer assistance with tax filing. These efforts will expand through an allocation of a staff person who will catalogue all income tax filing services available in the community, work with partners to coordinate efforts so that OW clients and low income earners within our community will be served.
- b. This area of effort is considered a best practice and is in alignment with the Provinces Digital Government Action Plan.

5.3 Area of Effort #3: Realizing Disability Benefits

It is generally accepted as true that there are Canadians eligible for disability benefits who do not apply for them. There are presumably Durham residents with disabilities who are eligible for Federal and Provincial disability benefits. Determining eligibility for these benefits via an income tax return can be overwhelming. Accessing this benefit is an element of financial inclusion.

a. Securing local expertize to support this area of priority is being explored with community partners. OW staff currently review this area with eligible clients and provide support as needed.

5.4 Area of Priority #4: Canada Learning Bonds

There are Durham residents who are eligible for the Canada Learning Bond (CLB) who have not applied for it. CLB's are available to all low income Canadians. The government of Canada will contribute the first \$500 toward a learning bond. Young people with a learning bond are 50% more likely to attend post-secondary education than those without one. A CLB requires a bank account. Access to post-secondary education is an element of financial and social inclusion.

 Ontario Works offices in Durham currently offer assistance with securing a CLB. These efforts will be boosted through the allocation of addition staff.

5.5 Area of Priority #5: Benefits Eligibility Tool (pilot)

Durham residents and service providers have expressed that accessing services and benefits from various providers is confusing, and often difficult to access because of the often complicated paperwork. The inventory of benefits, subsidies, programs and services available to a given target population can be very large. Residents accessing service often rely on the service provider to have knowledge of that inventory. Service providers rely on informal networks to inform their learning. This is not reliable or comprehensive. A tool is under development in the Social Services department in cooperation with the Health Department that will inventory benefits based on specific population profiles with local data and services. Similar tools are being piloted in other places across Ontario. Staff have begun discussions with UOIT in the hope of having students create an app which would connect low income residents to benefits/local resources. This tool will be designed to be simple and for use by individuals or service providers. Once completed, this tool will be shared broadly. Accessing community and government benefits is an element of financial and social inclusion.

- a. This area of effort is in alignment with the Social Assistance Reform objectives.
- b. Early successes will include an effort to better align the work of the Health and Social Service Departments.

5.6 Area of Effort #6: Expansion of Family Support Workers role (pilot)

There are children in Durham Region who are not being supported financially by both parents. As of February 2017, child support income will no longer be deducted from Ontario Works benefits and pursuing that income will no longer be a condition of eligibility. There are dedicated staff called Family Support Workers housed in OW offices with family law expertise. OW offices across the province are exploring ways to utilize this expertise to benefit low income residents more broadly. For example, there may be residents receiving subsidized child care whose children do not benefit from child support due to real or perceived barriers to obtaining child support. Child support increases family income. Child support is an element of social and financial inclusion.

- a. A working group has been struck to explore ways to expand the reach of the Family Support Works expertise and have more children in Durham realize the benefits of being supported by both parents. Initial efforts include a team from both Income Support and Children's Services.
- b. This area of effort is in alignment with the Provincial objective Benefits Transformation and Human Service Integration.

5.7 Area of Effort #7: Trusteed Youth Plan (pilot)

Ontario Works offices serve youth that are 16 and 17 years of age. They are referred to as Trusteed Youth. Building on the success of similar programs, a plan is underway to pilot a change in the way trusteed youth are served. Changes include co-created, custom, incentivized service plans, dedicated caseworkers, working with trustees to provide a mentorship role and ensuring youth realize the benefits of all the above noted areas of effort. This plan includes a focus on health, recreations, job readiness, social inclusion and access to post-secondary education. The majority of trusteed youth reside in Oshawa.

- Ontario Works staff anticipate this shift in service to take place by December of 2016.
- b. This area of effort is in keeping with Ontario Student Assistance Reform.
- c. This area of effort broadens the current youth programming offered at the OW Employment Resource Centre and ensures trusteed youth receive wraparound services similar to the Learning Earning and Parenting (LEAP) program.
- d. This area of effort will contribute to an Oshawa Community Development Plan.
- e. The City of Oshawa is currently exploring ways to support the trusteed youth plan.

5.8 Area of Effort #8: Oshawa Community Development Plan

At the request of the City of Oshawa an Oshawa Development Plan is being explored. As indicated in report DS-15-211 (City of Oshawa) "community development plans are typically established through a public participation process in which a variety of community members and stakeholders contribute towards the formulation of goals and objectives to improve the quality of life within a defined area such as South Oshawa." This plan will focus on community supports more broadly, beyond financial interventions, and work to leverage the suite of services and programs in place. Community supports lead to financial and social inclusion.

- a. Both the City of Oshawa and the Social Services Department are currently exploring ways to allocate staff to this initiative.
- b. This area of effort is another initial step in the direction of a youth employment plan.
- c. Staff in OW offices will work with City of Oshawa staff dedicated to this Community Development Plan to boost the success rates of the all areas of effort within the Financial Empowerment Framework, specifically in priority

neighborhoods.

5.9 Area of Effort #9: Connect for Success

There are Durham residents who cannot afford access to the internet or whose access consumes a large percentage of their household budget. Access to the internet is critical to students, banking, labour market attachment and social inclusion. In July of 2016 Rogers launched the Connect for Success program in Durham Region. This program offers internet access for residents who are currently in Rent Geared to Income housing units. Access to the internet is an element of social and financial inclusion.

- a. This area of effort aligns with the governments Digital Action Plan.
- b. This area of effort aligns with a future Youth Employment Strategy.
- c. This area of effort aligns with a Oshawa Community Development Plan.
- d. A future working group will be struck to explore ways to encourage residents to participate.

5.10 Area of Effort #10: Social Investment Fund, within the Income and Employment Support Division

- 5.11 The Social Investment Fund (SIF) was originally encouraged by the Province as a reinvestment of savings due to provincial social assistance benefits rate restructuring/upload. The restructuring of the benefit cost share ratio will be completed in 2018. Currently, the Social Investment Fun supports external agencies/projects in the community which focus on food security, education, brain injury supports and suicide support services. SIF funding is also accessed by OW caseworkers to assist clients in a broad range of supports to address hardship/poverty reduction, financial empowerment, social inclusion, and social determinants of health, Health Neighbourhoods Report, and preparing for the workplace. Sustained funding levels inside the SIF fund will continue to support a strong social infrastructure and contribute to a long term poverty reduction strategy.
 - a. This area of effort strengthens local services' ability to meet the needs of the community.
 - b. This area of effort aligns with the Department's overall poverty reduction and financial empowerment framework.
 - c. This area recognizes and supports the needs outlined within the Health Neighbourhoods Report.
 - d. This area of effort aligns with our corporate values to support a high quality of life for all residents.

6. Child Poverty Reduction Efforts – Re: \$100,000 Allocation

6.1 Staff within the Social Services Department utilized the additional resources within this \$100,000 allocation by providing direct support and benefits to families with children in Durham. The funding can be attributed to the following activities:

Up to \$100,000 – Children's Major Dental Treatment

Prior to 2016, families with children in receipt of Ontario Works assistance would receive dental coverage as part of their benefits eligibility within the program. Effective January 2016, children 17 and under were automatically enrolled in Healthy Smiles Ontario, under the Ministry of Health and Long-Term Care, when their families are in receipt of social assistance (e.g. Ontario Works).

As identified within the "Building on Health in Priority Neighbourhoods" report from the Health Department, it was noted that children growing up in poverty are more likely to experience a variety of health problems and have less access to supports such as dental care. Staff within Social Services along with staff within the Oral Health Division of the Health Department identified that there were dental procedures for children that are not covered under the Healthy Smiles program.

As a result, it is planned to allocate up to \$100,000 for procedures related to major orthodontic treatment for children in immediate need of support.

It is anticipated that if the full cost of the program is realized in 2016, the additional investments indicated below will be absorbed within the Social Investment Fund allocation budget for the Income and Employment Support Division.

\$4,500 - Children's Literacy Investment

Children's books and early learning supports were provided to Ontario Work's Offices within Durham. These new books and other items were available to families with children that were in receipt of assistance. The intent of the investment was to directly address barriers to child literacy that our most financially vulnerable populations face in Durham.

\$2,000 - Young Parents Food and Nutrition Program (Oshawa and Beaverton).

The purpose of this program was to increase food security for low income young families by providing healthy affordable meals and life-skills teaching for cooking and food budgeting. Each family will be provided with food items needed for a meal. Each session will have a cooking lesson where participants learn healthy alternatives, basic food pantry necessities and how to budget for meals.

This program is being administered, in partnership, with the YMCA within Durham.

7. Conclusion and Next Steps

- 7.1 Addressing poverty, and even more specifically child poverty in Durham, requires a coordinated and collaborative effort where several stakeholders and levels of government come together. Staff have responded to this need with the development of a financial empowerment framework. This has created an opportunity to develop deliberate streams of work intended to increase income levels of low income residents' long term and meet the needs of a variety of stakeholders and considerations.
- 7.2 Over the course of the next 12 18 months, the success of each area of effort will be assessed and next steps will be determined. Additionally, the impacts of provincial and federal initiatives named in Section 3 of this report will be assessed. These assessments could serve to inform a long term poverty reduction strategy to bringing all efforts under a single umbrella and a more coordinated strategic approach to poverty reduction.
- 7.3 Opportunities to deploy the areas of effort named in this framework more broadly in the community are being explored via a current open call for proposals.
- 7.4 The additional allocation of \$100,000 to the Health and Social Services Budget has created an opportunity for the departments to provide direct support to the health and well-being of children experiencing poverty in Durham.

Dr. Kyle, Commissioner of Health, and Medical Officer of Health has reviewed this report and concurs with its content.





Ontario Field Ornithologists (OFO) Honour Durham Region Finance and Works Departments with a Certificate of Appreciation at the AGM in Kingston September 2016

Nominated by OFO Life Member Geoff Carpentier.

Over the past 14 years Durham Region has cooperated with the local birding community to put a permit system in place that allows birders access to the lagoons during the spring, summer and fall and to enhance wildlife opportunities at the lagoons.

This year they are undergoing an extensive expansion of the sewage treatment facilities and consulted with Geoff Carpentier and Margaret Bain during the Environmental Assessment process to advise them on how the project might impact birds both during and after construction. Also this year there was an incident where new power lines were installed on one of the berms of the lagoons that Geoff felt might pose a threat to waterfowl, terns and shorebirds. When he told them they immediately undertook a project to assess the potential impact and have hired a consultant to determine if the lines should be moved and if so how best to do so. Finally, this season they started flooding the south lagoon where most of the shorebirds were and as soon as Geoff told them that this was critical habitat and very unfortunate timing, they immediately stopped and used another lagoon for their storage. They also promised to talk to Geoff in future before undertaking activities that might impact wildlife negatively.

The Finance Department initiated on online and in person option for permit acquisition that will make it much easier for out of town birders to get a permit. The birding community greatly appreciates this initiative.

4. Presentation

- A) Diana Chappell, Program Manager, Housing Services, Social Services

 <u>Department, Region of Durham, re: An Overview of the DASH Vacancy Site</u>
 - J. Traer advised that D. Chappell would not be able to attend the meeting until later. It was the consensus of the Committee that her presentation be heard later in the meeting. [See pages 3 and 4 of these minutes].

7. Reports

A) <u>Education Sub-committee Update</u>

M. Cordahi advised that she will look into a future presentation from the Access and Support Centre of Durham College. J. Traer advised that she will look into a future presentation regarding Building and Accessible Housing as well. J. Traer also advised that there is an Age-Friendly Community Forum scheduled for September 30, 2016 at Deer Creek Golf & Banquet Facility in Ajax. She stated that a staff member will be invited to provide a future presentation regarding the forum.

Discussion ensued regarding the importance of care for young people with disabilities as well as the aging population.

B) <u>Update on the Transit Advisory Committee (TAC)</u>

M. Sutherland advised that she did not have an update as the TAC meeting scheduled for September 13, 2016 was cancelled.

C) <u>Update from the Accessibility Coordinator</u>

- J. Traer provided an update on the following matters:
 - The Honourable Tracy MacCharles, MPP, is scheduled to speak at the Joint AAC Forum. 42 attendees are planning to attend. The Oshawa AAC will not be attending as their AAC meeting is scheduled for the same time.
 - The Honourable Carla Qualtrough, Minister of Sport and Persons with Disabilities, was invited to speak on August 23, 2016 at the Abilities Centre with regards to the launch of an in-person consultation process on accessibility legislation.

- The Paralympic Games in Rio are now over. There were 49 Ontario athletes that formed part of the Canadian team that competed in 19 of 23 events. Canada finished 14th in overall medal standings.
- The Regional Municipality of Durham's 2016-2021 Multi-year Accessibility Plan was approved by Regional Council on September 14, 2016. Staff is working on the 2016 Accessibility Report, which will be presented to Regional Council in December.
- The Works Department is working on the installation of the accessibility buttons of the south entrance doors of Regional Headquarters.
- The Works Department has plans to install accessibility buttons in the washrooms of the POA Department.
- The Region is working on implementing a new website in 2017. The new website will be user friendly, community friendly and accessible. Regional staff is currently learning how to create accessible documents so that all documents on the regional website are in an accessible format.
- The Dream Gala will be held at the Abilities Centre on October 22, 2016. Any committee members interested in attending were asked to advise J. Traer so that she can order tickets. Detailed discussion ensued with regards to difficulties with the food stations at the Gala; and the need for members to be seated close to the speakers and the closed-captioning screen.

4. Presentation

- A) Diana Chappell, Program Manager, Housing Services, Social Services

 Department, Region of Durham, re: An Overview of the DASH Vacancy Site
 - D. Chappell, Program Manager, Housing Services, provided a presentation regarding an overview of the Durham Access to Social Housing (DASH) vacancy site.
 - D. Chappell stated that the DASH Vacancy Site is a new on-line tool that was launched on August 19, 2016. It enables applicants waiting for rent-geared-to-income (RGI) housing in Durham to access an on-line waiting list. She stated that when an RGI unit becomes available, it is posted on the website. Interested persons must be on the waiting list in order to view and express an interest in the RGI vacancies. They are offered housing if their name is higher on the waiting list than other people expressing an interest in the same vacancy. She stated that this new program changes how housing subsidy is offered and addresses the ever changing needs of people looking for housing. It gives people the opportunity to take responsibility for where they want to live and when they want to move.

- D. Chappell stated that although many people do not have access to the internet, the site can be accessed through mobile devices, computer libraries, senior centres, and Regional headquarters.
- D. Chappell responded to questions with regards to whether there has been an increase in the number of vacancies; whether there are any accessible rent-geared-to-income units; and the possibility of builders creating more accessible units.

8. Administration Matters

There were no administrative matters to be considered.

9. Other Business

A) Closed Captioning of Televised Regional Meetings

Discussion ensued with regards to the importance of having televised regional meetings closed captioned; the costs involved in providing that service to the community; whether it is a human rights issue; and the possibility of having a representative from Durham DEAF Services as well as Rogers Communications provide the committee with an update.
