<sup>1.</sup> The Regional Land Division Committee (LDC) was created by Regional Council on December 19, 1973 to make independent decisions on the disposition of consent applications (e.g. severance, right-of-way, lot line adjustment) that have been submitted to the Region for approval under the Planning Act. The Committee consists of eight lay-citizen members (one representing each area municipality), that are appointed by Council for a four year term. The Chair of the LDC is selected from among the appointed members. The current Chair is Jane Hurst, the City of Oshawa's representative. The LDC meets monthly and considers approximately 150 consent applications per year.

#### 1. Purpose

1.1 The purpose of this report is to inform Council of the recent funding announcement for the expansion of natural gas to Scugog Island.

#### 2. Background

2.1 In January 2017, the Province of Ontario launched the Natural Gas Grant program to help to fund the building of new natural gas infrastructure in northern, rural, and First Nations Communities. The focus of the program is to accelerate projects with economic development potential, including agri-business and rural business projects

#### 3. Funding announcement for Scugog Island

3.1 On April 3, 2018, the Province of Ontario announced \$6,324,000 in funding to construct a reinforcement and distribution pipeline to connect homes and businesses located on Scugog Island which will be completed by Enbridge Gas Distribution.

3.2 On April 27, 2018, an official on-site announcement of the funding was made by Enbridge Gas Distribution and the Member of Provincial Parliament for Durham, Granville Anderson. Members of the Township of Scugog Council and staff were also in attendance.

#### Report:

#### 1. Purpose

1.1 The purpose of this report is to summarize the investment attraction activity handled by the Economic Development and Tourism Division in the first quarter of 2018.

#### 2. Background

- 2.1 The Economic Development and Tourism Division's investment attraction activities are focused on four areas: (i) Generate and source leads for potential new investment, including FDI missions, and hosting investor tours and delegations; (ii) Respond to investment inquiries; (iii) Promote the Region among the real estate and development community; and (iv) Cultivate relationships with Toronto Global, as well as the Federal and Provincial Governments to promote investment attraction to Durham.
- 2.2 In the first quarter of 2018, the Investment Attraction team secured two new investments (ie. wins) in the Region. Details of these investments can be found in Appendix 1 of this report.
- 2.3 In the first quarter of 2018, the Investment Attraction team handled fourteen investment leads, thirteen of these leads came directly to the Region or through the

- Region's global investment missions. One of these investment leads came through an outside agency. Details of these leads can be found in Appendix 2 of this report.
- 2.4 The leads came from three sectors: Health Sciences (11); Innovative Technology (2); and Food & Beverage (1).
- 2.5 Thirteen of the Investment leads from Q1 are currently "Open" and still considering their investment plans. One investment lead is "Closed".
- 2.6 The Investment Attraction team has categorized potential investors based on level of commitment and planned investment time horizon. See Attachment #1 for an overview of the Durham Region Economic Development Sales Funnel, which includes a definition of the categories 'Lead, 'Prospect', 'Opportunity', and 'Active Investor'.
- 2.7 One investment mission was undertaken by Regional Economic Development staff in Q1 to the MedLab conference, with mostly Eurasian Life Science exhibitors. Details of this mission can be found in Appendix 3 of this report.
- 2.8 In Q1, Economic Development and Tourism staff hosted two investors. Details of these investor visits can be found in Appendix 4 of this report.
- 2.9 Economic Development and Tourism staff hosted three in-bound delegations.

  Details of these delegations can be found in Appendix 5 of this report.

#### 3. Conclusion

- 3.1 In the first quarter of 2018, the Investment Attraction team secured two new investments, responded to fourteen investment inquiries, undertook one investment mission, hosted three investor visits, and organized three in-bound delegations.
- 3.2 The Investment Attraction team, in cooperation with the Durham Economic Development Partnership, is continuing to deliver its 2018 work plan to promote the Region in international markets as a municipality that is "open for business".

You may also wish to browse the online Health Department Reference Manual available at Board of Health Manual, which is continually updated.

Boards of health are required to "superintend, provide or ensure the provision of the health programs and services required by the [Health Protection and Promotion] Act and the regulations to the persons who reside in the health unit served by the board" (section 4, clause a, HPPA). In addition, medical officers of health are required to "[report] directly to the board of health on issues relating to public health concerns and to public health programs and services under this or any other Act" (sub-section 67.(1), HPPA).

Accordingly, the Health Information Update is a component of the Health Department's 'Accountability Framework', which also may include program and other reports, Health Plans, Quality Enhancement Plans, Durham Health Check-Ups, Performance Reports, business plans and budgets; provincial performance indicators and targets, monitoring, compliance audits and assessments; RDPS certification; and accreditation by Accreditation Canada.



WHEREAS homes and public spaces, such as schools, parks and workplaces, are often located next to buildings containing hazardous building materials, which are being altered, renovated and/or demolished.

Dear Mayor/CAO/Stakeholder:

As you know, in December 2017 the province introduced a new regulation, Ontario Regulation 588/17 Asset Management Planning for Municipal Infrastructure, under the Infrastructure for Jobs and Prosperity Act, 2015. The new regulation builds on the province's 2012 Guide to Asset Management Planning and is the critical next step for advancing evidence-based decision-making.

As part of our consultations on the regulation, we heard from municipalities that tools and supports are needed to help implement the requirements. That is why, as part of the introduction of the new regulation in December 2017, we committed \$25 million over five years to offer a suite of tools and supports. This commitment was reaffirmed in the 2018 Budget. I am pleased to share further details regarding this commitment. The province will deliver the tools and supports through a three stage plan.

The first stage will focus on spreading knowledge of best practices. As part of this stage, the province is partnering with Asset Management Ontario (AMOnt) on an initiative that will expand their community of practice work to municipalities across the province. Starting this year, AMOnt will deliver a series of activities, such as group seminars, online forums, peer reviews, and practitioner-led working groups. More information will be made available on their <a href="website">website</a> soon. We have also partnered with the Municipal Finance Officers Association of Ontario (MFOA) to create a toolkit to help municipalities develop a strategic asset management policy, which is required under the new regulation. This toolkit will be made available in the coming weeks on MFOA's website.

Under the second stage, the province is partnering with MFOA to provide small municipalities with in-person expert asset management plan assessments and localized action plans. Through this initiative, asset management experts will travel to communities, assess current asset management plans, identify opportunities for improvement, and provide expert advice that is tailored to the needs of each municipality. For some small communities with limited resources, this assistance may also include preliminary planning work (e.g. lifecycle costing) as time and program resources permit. This initiative will be implemented using a phased approach, starting with municipalities with populations under 5,000, and expanding to municipalities with populations up to 25,000 over time. MFOA will be connecting with eligible communities directly over the next few months.

In the third and final stage, the province intends to deliver a direct support program to municipalities that will build upon the progress made under the first two stages. This initiative will provide direct support to municipalities to help them complete asset management planning activities, such as condition assessments, levels of service measurements and lifecycle costing. Based on what we heard through consultations, we plan to target funding to small communities in particular. Through the Association of Municipalities Ontario (AMO) and other partner organizations, we look forward to hearing your feedback on the proposed program prior to launching in 2019. More details will be provided at that time.

Lastly, I am pleased to announce the completion of two additional tools that will further support municipalities in their asset management planning efforts. With previous funding support from the province, MFOA has developed an <u>Asset Management Community of Practice Guide</u> that will help municipalities come together to

establish their own community of practice, as well as an <u>Asset Management Self-Assessment Tool</u> that will let municipalities evaluate their asset management planning maturity.

Asset management planning is vital for the future of our communities and is more important than ever, given significant and growing infrastructure pressures and new challenges resulting from a changing climate. We are confident that the tools and supports that are being made available will help Ontario municipalities to better anticipate their infrastructure investment needs, prevent assets from deteriorating, save money over the long term, and ensure that local infrastructure supports the needs of their community.

Comme vous le savez, le gouvernement provincial a adopté, en décembre 2017, un nouveau règlement pris en application de la Loi de 2015 sur l'infrastructure au service de l'emploi et de la prospérité. C'est le Règlement de l'Ontario 588/17 (Planification de la gestion des biens pour l'infrastructure municipale). Le nouveau règlement fait fond sur le Guide relatif à l'élaboration des plans de gestion des infrastructures municipales (2012) et représente la prochaine étape cruciale pour faire progresser le processus décisionnel fondé sur des données probantes.

Dans le cadre de nos consultations sur le *Règlement 588/17*, les municipalités nous ont dit qu'elles ont besoin d'outils et d'un soutien pour les aider à observer les exigences. C'est pourquoi, dans le cadre de l'adoption du *Règlement 588/17*, en décembre 2017, nous avons prévu 25 millions de dollars étalés sur cinq ans pour offrir un ensemble d'outils et de mesures de soutien. Cet engagement a été réaffirmé dans le budget de 2018. J'ai le plaisir de vous communiquer d'autres renseignements au sujet de cet engagement. La province offrira les outils et le soutien par un plan comprenant trois étapes.

La première étape consistera principalement à diffuser des renseignements et à faire connaître les pratiques exemplaires. La province s'est associée à Asset Management Ontario (AMOnt) dans le cadre d'une initiative qui permettra d'étendre le travail de sa communauté de praticiens aux municipalités de toute la province. À compter de cette année, AMOnt offrira un ensemble d'activités qui comprendra notamment des séminaires, des forums en ligne, des examens par des pairs et des groupes de travail dirigés par des praticiens. AMOnt communiquera bientôt de plus amples renseignements à ce sujet au moyen de son site web. Nous nous sommes également associés à la Municipal Finance Officers Association of Ontario (MFOA) pour créer une trousse d'outils qui aidera les municipalités à élaborer une politique stratégique pour la gestion des biens, comme l'exige le nouveau règlement. La trousse d'outils sera offerte dans les semaines à venir au site Web de la MFOA.

Pour la deuxième étape, la province s'est s'associée à la MFOA pour fournir aux petites municipalités la possibilité de faire examiner leur plan de gestion des biens et leur plan d'action par des experts en gestion des biens. Ceux-ci examineront leur plan de gestion des biens et verront s'il est possible de les améliorer. Leurs conseils seront adaptés aux besoins particuliers de chaque municipalité. Dans le cas de certaines petites collectivités aux ressources limitées, cette aide pourrait aussi comprendre des travaux préliminaires de planification (p. ex. l'établissement du coût du cycle de vie des biens), si le temps et les ressources du programme le permettent. Cette initiative sera mise en œuvre par étapes, en commençant par les municipalités de moins de 5 000 habitants, puis en s'étendant petit à petit aux municipalités comptant jusqu'à 25 000 habitants. La MFOA communiquera directement avec les municipalités admissibles au cours des prochains mois.

Pour la troisième et dernière étape, la province a l'intention d'offrir un programme de soutien direct aux municipalités. Le programme s'appuiera sur les progrès réalisés au cours des deux premières étapes. Cette initiative fournira un soutien direct aux municipalités pour les aider à mener à bien leurs activités de planification de la gestion des biens, dont l'évaluation de l'état des biens, la mesure des niveaux de service et l'établissement du coût du cycle de vie des biens. D'après ce que nous ont dit les municipalités lors des consultations, nous avons l'intention de cibler le financement en particulier sur les petites municipalités. Par l'Association des municipalités de l'Ontario (AMO) et d'autres organismes partenaires, nous avons hâte de voir ce que vous pensez du programme proposé avant son lancement en 2019. Vous recevrez de plus amples renseignements à ce moment-là.

Enfin, j'ai le plaisir d'annoncer deux autres outils que nous avons créés pour aider encore davantage les municipalités à planifier la gestion de leurs biens. Grâce à une aide financière qu'elle a obtenue de la province, la MFOA a élaboré un guide intitulé *Asset Management Community of Practice Guide*, qui aidera les municipalités à se réunir pour établir leur propre communauté de praticiens. La MFOA a aussi créé un outil d'auto-évaluation de la gestion des biens qui permettra aux municipalités d'évaluer leur niveau de compétences dans la planification de la gestion des biens. Ces outils seront bientôt offerts au <u>site Web</u> de la MFOA.

La planification de la gestion des biens est d'une importance fondamentale pour l'avenir de nos collectivités. Elle est plus importante que jamais vu les pressions importantes et croissantes qui s'exercent sur les infrastructures et compte tenu des nouveaux défis que crée le changement climatique. Nous sommes convaincus que les outils et le soutien qui sont mis à la disposition des municipalités de l'Ontario les aideront à mieux prévoir leurs besoins en matière d'investissement dans les infrastructures, à prévenir la détérioration de leurs biens, à économiser de l'argent à long terme et à veiller à ce que leurs infrastructures répondent aux besoins de leur population.



### 1. Declarations of Interest

Councillor Drumm made a declaration of interest later in the meeting under the *Municipal Conflict of Interest Act* with respect to any items pertaining to Durham Region Transit. He indicated that his son is employed by Durham Region Transit.

# 2. Adoption of Minutes

# 3. Presentations

A) Line Millette, Emergency Management Coordinator, Durham Emergency Management Office (DEMO), regarding Alert Types for Emergency Response

L. Millette provided a presentation regarding the Durham Emergency Management Office (DEMO) and Alert Types for Emergency Responses.

She advised that DEMO is responsible for co-ordinating an emergency management program for Durham residents to prepare for, respond to, and recover from major emergencies.

- L. Millette advised that DEMO has been a formally recognized office since 1996 and inherited the Rapid Notify mass notification from DRPS. She stated that the primary focus of the Rapid Notify mass notification was in case of a nuclear emergency for Darlington and Pickering out to 10 km; a downloaded list of landline phone numbers only; a one way message from the Region to households and businesses; and does not include unlisted numbers or numbers on the "do not call" list.
- L. Millette advised that public alerting is paid for by the Ontario Power Generation (OPG) through a Memorandum of Understanding. She stated that DEMO has approached OPG to include a portion of Toronto within the Pickering nuclear zone; to increase the Rapid Notify contract limits to include all of Durham Region; and to bring local municipalities on board to allow them to issue their own emergency messages to their residents. She advised that DEMO now has sub-accounts under the existing Rapid Notify contract to allow for Toronto and the 8 area municipalities to create and push their own emergency messages, meaning full coverage for Durham Region.
- L. Millette stated that today, 95% of households have cell phones which are used as the primary means of communications. DEMO is working with the area municipalities to start a self-registration initiative through the Rapid Notify system. She advised that the self-registration will require residents to create an online account and complete a form to register for and receive alerts for their local area. She also advised that out-of-towners can sign up their out-of-town phone numbers with a local address to also receive notifications for a specific area that would affect loved ones. She advised that meetings are scheduled for May 10, 2018 to discuss this initiative with stakeholders.
- L. Millette also stated that as of April 6<sup>th</sup>, 4G Long Term Evolution (LTE) phones are able to receive emergency alerts. She advised that older phones will not have the technology and newer phones may have the technology but that the option to receive messages may be turned off and advised that citizens should contact their service provider to verify whether or not their phones can receive messages. As there will be a transition period for all cell phones to be compatible, the province will continue to issue red alerts along with cell broadcast messages for the next five years.
- L. Millette responded to questions of the Committee with regards to access to the registration forms on municipal websites; whether the registration forms can be mailed out to individuals without internet access or computers; whether other disasters get the same attention as nuclear safety and preparedness; and how cell phone towers are affected by natural disasters.

The Committee recessed at 1:45 PM and reconvened at 1:55 PM.

At this time, Councillor Drumm addressed the Committee with regards to National Volunteer Week. He spoke of the importance of volunteers and thanked committee members for their work and dedication.

### 5. Information Items

# A) <u>Education Sub-Committee Update</u>

J. Traer advised that two members from the 2019 Ontario Parasport Committee will be presenting at the May 22, 2018 meeting. She advised that there will not be any presentations at the June meeting.

# B) Update on the Transit Advisory Committee (TAC)

At this time, Councillor Drumm made a declaration of interest under the *Municipal Conflict of Interest Act* with respect to any items pertaining to Durham Region Transit. He indicated that his son is employed by Durham Region Transit.

M. Sutherland advised that there was a lack of quorum at the April 3, 2018 Transit Advisory Committee meeting. M. Roche advised that the details of Report #2018-DRT-08 regarding Durham-Scarborough Bus Rapid Transit were, however, reviewed at the meeting. He stated that the report provided information regarding the announcement of \$10 million of funding from the Province to advance project development work.

Discussion ensued with regards to the use of Uber in the Town of Whitby as well as the available taxi services in the Town of Whitby.

# C) Update from the Accessibility Coordinator

- i) J. Traer requested that committee members review the current AAC Terms of Reference and advise what their thoughts were on possible revisions to the timing of committee meetings. The following options were provided and it was the consensus of the Committee to discuss further at the May meeting:
  - Keep the same schedule and time
  - Keep the same schedule and change the time
  - Change the meeting schedule to quarterly meetings during the day or evening

Discussion ensued and following suggestions from the committee members were made:

- Have 6 meetings per year
- Quarterly meetings may not work due to timelines on projects
- Quarterly meetings may lose momentum and items that need approval would be delayed
- Leave the meeting schedule as is
- Have meetings every two months and sub-committee meetings on the months when the committee does not meet
- There may be transit issues with regards to evening meetings
- Increase the membership of the committee
- ii) J. Traer stated that the Dynamic Symbol of Access was adopted by the Township of Uxbridge. She advised that other municipalities may consider adopting the symbol in the future depending on provincial legislation.
- iii) J. Traer advised that as a follow up to the survey that was provided to members regarding best practices and challenges, the Accessibility Directorate has hired a consultant to facilitate focus groups to build on the feedback provided by way of the surveys. She advised that focus groups will be held by way of teleconferences.
- iv) J. Traer advised that the Accessible Employment Standards
  Development Committee is seeking public feedback to the
  recommendation report by way of a survey. The survey is available
  until May 5, 2018. J. Traer advised that she will provide the link to the
  survey and/or printed copies to committee members.
- v) J. Traer advised that she is working with DRT and several local accessibility co-coordinators with regards to setting up a meeting in June to discuss matters pertaining to accessibility and transit.
- vi) J. Traer announced that Gerri Lynn O'Connor was appointed as the Regional Chair and CEO on April 11, 2018. She advised that Regional Chair O'Connor is the fifth Regional Chair and the first female to hold the role of Regional Chair.
- vii) J. Traer advised that in celebration of the Canadian National Institute for the Blind's 100<sup>th</sup> Anniversary, there will be a 1918 themed tea party held on May 6, 2018 from 2 to 5 PM at the Ajax Lions Hall.

#### 6. Discussion Items

A) Forward Movement re: Dynamic Symbol of Access

# A) <u>Canadian Tire Jumpstart Charity – D. Campbell</u>

D. Campbell stated that Jumpstart Charities has been granted a \$50 million commitment over five years to provide children with disabilities greater access to sport and play. She advised that the money will go towards building accessible playgrounds and retrofitting existing community centres, parks and arenas to remove physical barriers.

### B) Youth Leads Project – D. Campbell

D. Campbell stated that the Harmony Movement is a leading provider of training programs promoting diversity, equity and inclusion. She stated that the movement has partnered with Durham Region to provide students in grades 5 to 12 with skill building workshops.
