Report:

1. Purpose

1.1 This report provides details related to the use of delegated authorities during the 2018 Regional Municipality of Durham (Region) Council summer recess period in accordance with the Region's Budget Management Policy.

2. Background

2.1 Section 16.0 of the Region's Budget Management Policy details the delegation of authority during a recess of Regional Council. In accordance with the requirements of this section, a report providing the details of the use of this delegated authority is to be presented to the Committee of the Whole within 30 days after the recess period. Dollar amounts followed by an asterisk (*) are before applicable taxes.

2.2 Sections of authority utilized during the 2018 Regional Council summer recess period include:

- a. Section 16.1 of the Region's Budget Management Policy, authorizing the Treasurer to recommend project financing to the Regional Chair and Chair or Vice Chair of the applicable Standing Committee for approval during a

recess of Regional Council.

- b. Section 16.2 of the Region's Budget Management Policy, authorizing the Regional Chair or Chief Administrative Officer (CAO), and the Chair or Vice Chair of the applicable Standing Committee to approve the acquisition of unbudgeted capital over \$25,000 during a recess of Regional Council.
- c. Section 16.4 of the Region's Budget Management Policy, which states that in order to facilitate the awarding of Request for Proposals and approval of sole source negotiations over \$125,000, the Commissioner of Finance is authorized to act on behalf of Regional Council, subject to the agreement of the applicable Department Head and CAO and the availability of sufficient funding, and, that the Commissioner of Finance be authorized to execute any resultant Agreements for the goods and services required.
- d. Section 16.5 of the Region's Budget Management Policy, which states that in order to facilitate the negotiation and approval of leases considered to be material (i.e. extension beyond the term of Council and/or annual payments of \$150,000 or greater) the Commissioner of Finance is authorized to act on behalf of Regional Council, subject to the agreement of the applicable Department Head and CAO and the availability of sufficient funding and the Commissioner of Finance be authorized to execute any resultant leases required.
- e. Section 16.7 of the Region's Budget Management Policy, authorizing Department Heads to obtain professional, consulting, engineering and/or architectural services in excess of \$60,000 during the recess period subject to approval by the Commissioner of Finance and CAO in accordance with established procedures and the provisions of the Purchasing By-Law.

3. Requests for Additional Project Financing as per Section 16.1

Additional Financing Required for the Construction of a new Pedestrian Walkway at Regional Headquarters, in the Town of Whitby (Project G1701)

- 3.1 This project includes the construction of a new concrete pedestrian walkway, installation of concrete curbs, illuminated bollards, and landscaping to improve pedestrian mobility and safety across the south parking area at Regional

Headquarters. The approved budget for this project was \$186,500, including the design and construction work for the new walkway.

3.2 Bid submissions were reviewed for Tender T-1049-2018 and based on the results of the tender process, the lowest compliant bid was submitted by E.T. Construction Inc. in the amount of \$169,658*. To award this contract, additional project financing of \$47,500 was required.

3.3 The additional financing was provided from the following source:

Regional Headquarters Capital Budget

Additional Financing Required for the Sunderland Exfiltration Lagoon Cleanout, in the Township of Brock (Project D1827)

3.4 This project includes the rehabilitation of the exfiltration lagoon constructed in Sunderland in the 1970s. The build-up of sewage sludge over time has reduced the operational effectiveness of the lagoon and has contributed to a lack of available seasonal storage capacity. The removal of the sewage sludge will restore the original function of the lagoon and provide the necessary seasonal storage capacity.

3.5 Bid submissions were reviewed and based on the results of the tender process, the lowest compliant bid was submitted by Todd Brothers Contracting Limited in the amount of \$2,210,947*. To award this contract, additional project financing of \$1,150,000 was required.

3.6 The current approved budget of \$1,000,000 was exceeded due to the amount of sludge contained in the lagoon being underestimated, affecting the costs to remove and dispose of the sludge material as well as the reinstatement of the exfiltration sand base.

3.7 The additional financing in the amount of \$1,150,000 was provided as follows:

Additional Financing Required for the Construction of the Britannia Avenue East Watermain, in the City of Oshawa (Project O1801)

- 3.8 To align with the City of Oshawa's priority Britannia Avenue Bridge project, the Region is connecting two dead end watermains that are currently on either side of the Oshawa Creek at this location. This work will improve water system security and water quality.
- 3.9 The intent is to install the watermain by hanging it from the underside of the bridge structure, which requires the watermain to be constructed at the same time as the bridge. This is a specialized method of construction. Consideration was given to more conventional approaches to the creek crossing, but these could not be utilized given the timeline for the City of Oshawa's plans to tender this project. There was insufficient time to secure approvals and the necessary technical information on which an alternative design would be based. The Region had budgeted \$300,000 for the design and construction of this watermain connection.
- 3.10 The tender was issued and bid submissions were reviewed by the City of Oshawa for Contract O18-08. The City of Oshawa awarded the contract to Kapp Contracting Inc. for a total value of \$5,951,654*, with the portion for the Region's work totaling \$391,120*. Additional project financing of \$340,000 was required as a result of this award.
- 3.11 The additional financing in the amount of \$340,000 was provided as follows:

2018 Water Supply Capital Budget

Item #17C – Town of Whitby Road Program (Project W1899) \$340,000

Additional Financing Required for the Construction of the Bus Rapid Transit Road Improvements, in the Town of Ajax (Projects R1303 and R1636)

- 3.12 Additional commitments to Esposito Bros. Construction Ltd. were required for additional work completed relating to Regional Contract D2016-033 for the Bus Rapid Transit Road Improvements on Westney Road (Regional Road 31) and Kingston Road (Regional Road 2), in the Town of Ajax.
- 3.13 Because of unanticipated conflicts with buried utilities, various design changes, inclement weather and additions to the contract, the current approved budget of \$5,831,533 was exceeded and additional contract costs in the amount of \$1,683,000* have been incurred resulting in the need for additional financing.

3.14 The additional financing in the amount of \$1,683,300* was provided as follows:

4. Request for Unbudgeted Capital over \$25,000 as per Section 16.2

Unbudgeted Capital Request for the Zone 1 Watermain Extension to Service the Uxbridge Fire Hall, in the Township of Uxbridge

4.1 The Township of Uxbridge is serviced by a municipal water system that is divided into two pressure zones. Most of the community is serviced by Pressure Zone 1 with Pressure Zone 2 servicing a small area in the northwest portion of the township.

4.2 Due to topography challenges in Pressure Zone 2, the reservoir elevation is too low to adequately pressurize Zone 2. To assist in drawing water from the reservoir, the water pressure is boosted by pumps.

4.3 The new Uxbridge Fire Hall opened in the spring of 2017 and is serviced by Pressure Zone 2. Firefighter training exercises conducted at the station were resulting in pressure drops in the water supply and causing operational issues for the Region, including routine alarms associated with the pumps.

4.4 In consultation with the Township of Uxbridge and the Uxbridge Fire Department, the Region examined options for improving the pressure issues experienced by the Fire Department and concluded that the best option was to extend a watermain from Pressure Zone 1 to the fire hall. The watermain would be used for training purposes only and should provide water at a pressure that would be sufficient for training purposes.

4.5 The Township of Uxbridge and the Region have agreed to cost share the extension of the watermain to the Uxbridge Fire Hall. The cost to the Region is estimated at \$140,000* with financing provided from a reallocation of funds within the 2018 Water Supply Capital budget as follows:

Unbudgeted Capital Request for the Duffin Creek Water Pollution Control Plant Security Guardhouse Retrofit, in the City of Pickering

- 4.6 This project includes technical and structural upgrading of the security guardhouse to more adequately meet the increased traffic flows resulting from recent and current plant expansion work, the increased number of employees, and more frequent hauler and delivery traffic.
- 4.7 The work will include a license plate recognition system and security cameras to help expedite staff entry to the facility while identifying vehicular traffic that requires further scrutiny before being granted entrance to the property.
- 4.8 This retrofit will bring the procedures and equipment of the guardhouse in line with current Regional security practices and other industry recommended security standards.
- 4.9 The estimated cost of this work is \$50,000 with financing reallocated from within the Sanitary Sewerage Capital budget as follows:

5. Request for Award of Request for Proposals and Sole Source Negotiations as per Section 16.4

Engineering Services Agreement for Groundwater Modelling Updates in the Region (Project M0101)

- 5.1 RFP-1102-2018 for consulting engineering services for Groundwater Modelling Updates was released on March 5, 2018.
- 5.2 Based on the results of the evaluation process, RFP-1102-2018 was awarded to S.S. Papadopoulos & Associates at an upset limit not to exceed \$268,280* including disbursements.
- 5.3 Financing for the engineering services contract was provided from within the approved project budget.

Engineering Services Agreement to provide Ambient Air Monitoring and Reporting Services at the Durham York Energy Centre, in the Municipality of Clarington

- 5.4 RFP-1002-2018 for consulting engineering services to provide Ambient Air Modelling and Reporting Services at the Durham York Energy Centre over a four-year term was released on April 5, 2018.
- 5.5 Based on the results of the evaluation process, RFP-1002-2018 was awarded to RWDI Air Inc. at an upset limit not to exceed \$788,800* including disbursements over a four-year term.
- 5.6 Financing for the engineering services was provided from the 2018 and subsequent Solid Waste Management Operating Budgets for the Durham York Energy Centre.

Engineering Services Agreement for the Environmental Impact Study and Detailed Design for the Reconstruction of Zephyr Road, in the Township of Uxbridge (Project R1503)

- 5.7 RFP-1026-2018 for consulting engineering services for the Environmental Impact Study and Detailed Design for the Reconstruction of Zephyr Road (Regional Road 13) from Regional Road 39 to Concession Road 4, in the Township of Uxbridge was released on May 15, 2018.
- 5.8 Based on the results of the evaluation process, RFP-1026-2018 was awarded to BT Engineering at an upset limit not to exceed \$191,165* including disbursements.
- 5.9 Financing for the engineering services agreement was provided from the approved project budget.

Sole Source Approval for Maintenance Service and/or Parts Supply Agreements for Equipment Installed at the Duffin Creek Water Pollution Control Plant (WPCP), in the City of Pickering

- 5.10 The Region and the Regional Municipality of York pre-purchased several major equipment components as part of the Stage 3 expansion activities and the Stage 1 and 2 Upgrade projects at the Duffin Creek WPCP.
- 5.11 Often, consumable spare parts, replacement components and other maintenance items can only be obtained through the original vendor or their authorized Ontario

representative, resulting in the requirement for sole sourced maintenance service and/or parts supply agreements.

- 5.12 For the equipment and services intended to be covered under the proposed agreements, the Ontario based authorized distributor or the manufacturer have been identified as OVIVO, PRO AQUA and Envirocare. In cases where more than one authorized distributor is located, the established competitive process will be followed.
- 5.13 Agreements will be negotiated for a period of up to five years, beginning in 2019, with an estimated annual cost of \$925,000*, with financing provided from the Sanitary Sewerage Operating budget for Duffin Creek WPCP.

6. Request for Approval of Lease Negotiations as per Section 16.5

Approval of Offer to Lease between the Region of Durham and 2389343 Ontario Inc. for the Durham Region Police Service Community Police Centre, in the Township of Uxbridge

- 6.1 The Durham Region Police Service (DRPS) have operated a community police centre in Uxbridge since 2002. Due to construction works in Uxbridge, the location occupied by DRPS is scheduled to be demolished.
- 6.2 To address DRPS' request to maintain a location in Uxbridge, a new office located at 307 Toronto Street, Unit #11 has been leased for a five-year term with annual lease payments of \$21,462 plus taxes, maintenance, insurance and utilities.
- 6.3 Financing for this Offer to Lease Agreement will be provided from the approved 2018 and subsequent Durham Region Police Service Operating budget for this facility.

7. Request for Approval of a Professional, Consulting, Engineering and/or Architectural Services Agreement as per Section 16.7

Engineering Services Agreement Awarded to The Municipal Infrastructure Group for the Detailed Design and Tender Preparation for the Krosno Creek Sanitary Sewer Replacement and Watermain Replacement on Sandy Beach Road, in the City of Pickering (Projects P1701 and P1702)

- 7.1 An engineering services agreement with The Municipal Infrastructure Group (TMIG) is has been entered into for the detailed design and tender preparation

for the proposed Krosno Creek sanitary sewer replacement and the replacement of a watermain on Sandy Beach Road, in the City of Pickering.

- 7.2 This project will take place in conjunction with the City of Pickering's project to reconstruct Sandy Beach Road, from Bayly Street to Montgomery Park Road. TMIG has been retained by Pickering to undertake a Municipal Class Environmental Assessment and detailed design for the project.
- 7.3 An upset limit of \$96,567* including disbursements has been established for this agreement, with financing provided from the approved project budgets.

(1), HPPA).

Accordingly, the Health Information Update is a component of the Health Department’s ‘Accountability Framework’, which also may include program and other reports, Health Plans, Quality Enhancement Plans, Durham Health Check-Ups, Performance Reports, business plans and budgets; provincial performance indicators and targets, monitoring, compliance audits and assessments; RDPS certification; and accreditation by Accreditation Canada.

1. Registration

Those in attendance took the opportunity to meet and greet other AAC members.

2. Opening Remarks

A. Gibson, Director of Corporate Policy and Strategic Initiatives, Office of the Chief Administrative Officer, welcomed new and returning members to the Joint Forum of the Accessibility Advisory Committees.

3. Presentation - Universal Design – Thea Kurdi

A. Gibson introduced Thea Kurdi, Associate Accessibility and Universal Design Specialist, Designable Environments. A. Gibson stated that T. Kurdi has presented workshops, keynote addresses and lectures at local and international events for design professionals, building owners, and policymakers. She stated that T. Kurdi shares her passion for how accessibility is fundamental to successful architecture.

T. Kurdi provided an informative and engaging PowerPoint Presentation with regards to the creation of accessible environments through the application of regulations and universal design principles. She stated that approximately 1.9 million people report having a disability in Ontario, representing 15.5% of the population.

T. Kurdi stated that a disability can be categorized as a: mobility impairment; visual impairment; hearing impairment; cognitive impairment; learning disability; deaf-blind; speech and language impairment; dexterity impairment; and older persons, however, 70% of disabilities in general are “invisible” and can also include older persons, homeless persons with disabilities, overweight/larger people, children with disabilities, temporary disabilities and functional abilities. She advised that older persons have the highest disability rate of any group.

T. Kurdi provided an overview of universal design and advised that universal design addresses anthropometric requirements and needs for: women and shorter people; seniors; children with disabilities; families; people with mental disabilities; people who are short or little people; and people who do not read or speak the English language. She advised that there are 7 principles of universal design as follows:

- Equitable use
- Flexibility in use
- Simple and intuitive use
- Perceptible information
- Tolerance for Error
- Low Physical Effort
- Size and Space for Approach and Use

T. Kurdi reviewed the principle of Life Cycle Costing and provided the following examples of alternatives that can be incorporated and can impact both pending and future costs: drop off; rest areas; animal relief areas; doors; barrier-free washrooms; bathroom grab bars; toilets; kitchens; accessible recreation facilities; colour contrast; signage/wayfinding; track and recycling; laundry; and gardens.

T. Kurdi reviewed the legal requirements for accessibility as stated in the following two legislations: Ontario Building Code (OBC) 2012 and the Accessibility for Ontarians with Disabilities Act (AODA). She stated that homes should be 100% visit-able and adaptable for the following reasons: statistics; demographics; international agreements (Federal and Provincial laws); safer; homes are made easier to use by all family members and visitors; increased ability to live independently for longer; flexibility to adapt to changing needs of family members which makes future renovations less expensive; and market advantage.

T. Kurdi stated that the biggest mistake when designing homes, is to design for the able-bodied only.

The Committees recessed at 6:56 PM and reconvened at 7:10 PM.

4. Presentation - Barrier Free Fully Accessible Washroom Trailer – Derek Bunn

A. Gibson introduced Derek Bunn, Special Education Teacher, Sutton District High School, York Region. A. Gibson stated that D. Bunn has been supporting young adults in education and adults in Community Living for 20 years. D. Bunn has experience working with children with physical disabilities, young adults who are non-verbal and students with autism, cerebral palsy, global developmental delay, and multiple sclerosis. Through his experiences he recognized a lack of support systems for children, adults and seniors living with physical disabilities. As a special education teacher with the York Region District School Board, D. Bunn advocates for change in his community and has worked to create the barrier free fully accessible washroom.

D. Bunn stated that the following reasons are behind his proposal for a barrier free fully accessible washroom:

- Improve accessibility – to purchase a barrier free mobile washroom trailer that would be used exclusively by children, adults, seniors who cannot use the existing “handicapped” washroom/stalls because of severe physical needs
- Respect and dignity – to provide a respectful location/accommodation for severely disabled children/adults/seniors for medical and hygiene needs
- Integration/participation – to assist physically disabled children, adults and seniors to participate in their community and to live meaningful lives

D. Bunn stated that there are no washrooms with change tables and lift systems in York Region to assist the population of severely physically challenged children, adults and seniors with medical needs. As a result, this population is not accessing the many fairs, events and festivals offered in their community. He stated that currently there are usually 1 or 2 large handicapped stalls or portable units for people who can transfer themselves from their wheelchair and back. People with severe physical challenges must either be lifted from their wheelchair onto a floor or be left unchanged.

D. Bunn stated that interior features of the barrier free fully accessible washroom trailer include: lift system; change table; sink; toilet; air-conditioning; electric heat; water tank; push button door opening/lock; call/emergency button; and automatic doors. He stated that the trailer was first unveiled at the Invictus Games Toronto 2017 and since then has been at the following events: official ribbon cutting ceremony in Stouffville (2018); BBQ fest in Georgina (2018); Ribfest in Stouffville (2018); Ribfest in Aurora (2018); Student Hoedown/Magna Hoedown in Aurora (2018); Fall Fair in Markham (2018); and the Buttertart Festival in Georgina (2018).

D. Bunn stated that the purchase price of the trailer is \$125,000 plus tax. He advised that the operational cost is \$500 per event and stated that showing support of the barrier free fully accessible washroom will have a significant impact on assisting children, adults and seniors live better lives in their communities.

5. Accessibility Awards Presentation

A. Gibson advised that The Regional Municipality of Durham recognizes the importance of an accessible community. A. Gibson advised that each year the Regional Municipality of Durham honours individuals, services or local businesses that have improved accessibility in their community. Nominations for the Awards are made by the local Accessibility Advisory Committees of the municipalities within Durham Region. A Gibson stated that each award recipient has succeeded in removing or preventing a barrier and their efforts have helped to ensure that citizens have access to meaningful involvement and full participation in their community.

M. Sutherland and S. Sones joined A. Gibson to present the awards and thank each recipient.

Town of Ajax – Award Recipient – Olivia Rennie

A. Gibson advised that Ms. Rennie recently graduated from the University of Toronto, completing her studies in neuroscience and psychology. Ms. Rennie has always wanted to make a difference in the accessibility community and was inspired to pursue these dreams after taking Politics of Disability, a course taught by former Lieutenant Governor and accessibility advocate, David Onley. Over the years, she has collaborated with University of Toronto's accessibility services and has worked alongside faculty regarding the development of a new Disability Studies program. Ms. Rennie also volunteers with the Hospital for Sick Kids and the Distress Centre in Durham and has partnered with the Town of Ajax as a Youth Accessibility Leader.

Ms. Olivia Rennie accepted the award and congratulations from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

Township of Brock – Award Recipients – Beaverton Legion Branch 135

A. Gibson stated that Beaverton Legion Branch 135 has gone above and beyond in their efforts to become a barrier free environment. They were rewarded with a Trillium grant from the Provincial Government in 2014, which they used to install barrier free doors to the entrance of their building. Following the installation of the barrier free doors, they received the official designation as a disaster relief centre for the community of Beaverton. In 2016, they received a New Horizons for Seniors grant which was used to install barrier free doors for both the ladies and men's washrooms. Accessible doors to get into and within their branch is an asset for their members.

Mr. Bob Page, Treasurer of the Beaverton Legion Branch 135, accepted the award and congratulations from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

Municipality of Clarington - Award Recipients – Swiss Chalet

A. Gibson advised that the Swiss Chalet Restaurant in Bowmanville has shown their willingness to support persons with disabilities by hiring and providing meaningful work for them. Doing so gives their employees the opportunity for a positive experience, adding to their self worth and self esteem and allowing them to contribute to their community. The building has an accessible door entry and the staff are very supportive in providing any assistance that may be required.

Mr. Tim Van Leeuwen, Clarington AAC member and Ms. Andrea Nicholson, Accessibility Coordinator, Clarington AAC, accepted the award and congratulations on behalf of Mr. Mark Chen, General Manager of the Bowmanville Swiss Chalet from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

City of Oshawa – Award Recipient – Marko Ivancicevic

A. Gibson advised that Mr. Ivancicevic joined the Oshawa Accessibility Advisory Committee in 2010 and has been instrumental in the creation of a medical marijuana working group committee that has researched and provided education about the medicinal benefits of cannabis for people with disabilities and the legislated changes as it relates to the municipality.

Mr. Marko Ivancicevic accepted the award and congratulations from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

Township of Scugog – Award Recipient – Tara Sneath

A. Gibson advised that Ms. Tara Sneath is a teacher at the Practical Learning Program at Port Perry High School. She has been instrumental in creating an awareness of the diverse employment and social needs of individuals with disabilities, providing insight and education to the Accessibility Committee and staff at large about the diversity of accessibility needs in the community, as well as highlighting the need for AODA compliance for accessibility and a “person centered” approach.

Ms. Tara Sneath accepted the award and congratulations from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

Township of Uxbridge – Award Recipient – Jodi Bussiere, Uxbridge Physiotherapy

A. Gibson advised that Ms. Jodi Bussiere is the owner of Uxbridge Physiotherapy, which has been serving the Uxbridge and surrounding areas for over 15 years and has a solid reputation within the local health care community. A. Gibson advised that Uxbridge Physiotherapy has moved to an accessible location to better serve their patients with mobility and accessibility challenges. A. Gibson advised that Ms. Bussiere treats people of all ages and abilities and believes in the team approach to treatment. Ms. Bussiere and her team exemplifies accessibility leadership not just through access to their building but also with their commitment to accessible customer service.

Ms. Jodi Bussiere accepted the award and congratulations from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

**Town of Whitby – Award Recipient – Nelly Temraz, JointAction
Physiotherapy & Wellness Centre**

A. Gibson advised that Ms. Nelly Temraz is a Physiotherapist and owner of JointAction Physiotherapy & Wellness Centre. The Home Care Physiotherapy program at JointAction Physiotherapy & Wellness Centre caters to those who require physiotherapy services, but have difficulty leaving their home due to mobility issues. The program allows for a Registered Physiotherapist to visit a client's home to assist in recovery from surgery, increase mobility or better adapt to their home environment. The visit includes a thorough assessment and treatment plan and is offered in Whitby, Brooklin, Oshawa and Courtice.

Ms. Nelly Temraz accepted the award and congratulations from M. Sutherland, Chair, and S. Sones, Vice-Chair of the Durham Region AAC.

A. Gibson thanked all the recipients for their leadership and commitment in make Durham a more inclusive and accessible region.

6. Presentation – Accessible Play Spaces for All – Dawn Campbell

A. Gibson introduced Dawn Campbell. She stated that D. Campbell is a passionate educator and has dedicated over 20 years to breaking down barriers for people with disabilities. She was awarded the International Day for Persons with Disabilities Access Award for Kingston in 2011. D. Campbell has worked for the Canadian Paralympic Committee, the Rick Hansen Foundation, and has recently joined Onix Canada where she will continue to work nationally in accessibility to help governments, higher education, school boards and companies become compliant to information and technology for accessibility legislation.

D. Campbell provided a PowerPoint Presentation regarding Accessible Play Spaces for All. She stated that it's important to understand the demographics, the statistics and the law with regards to accessible play spaces. She stated that play is essential for a child's physical, social, and emotional well-being and that physical activity is associated with a reduced risk of over 25 chronic conditions. Play encourages children to solve problems, make decisions, interact with people and objects, develop language, and encourage symbolic thinking. She stated that children with disabilities have a higher risk of social isolation and experience less diversity of activities and less social activities.

D. Campbell stated that accessible playgrounds can include separate swings to cater to kids with autism etc., sun shades, raised sandboxes, swings for families, sensory playgrounds (with sound garden, fragrance garden, musical areas), and adult playgrounds with equipment. She stated that there are many online courses and information to get better acquainted with accessibility in play spaces.

7. Adjourment

A. Gibson thanked everyone for attending the meeting and for their dedication and hard work in making accessibility a priority.

The meeting adjourned at 8:27 PM.
