Report:

1. Purpose

1.1 The purpose of this report is to inform Council of a Climate Change Symposium being jointly hosted by the Durham Agricultural Advisory Committee (DAAC), Durham Environmental Advisory Committee (DEAC) and Durham Region Roundtable on Climate Change (DRRCC), on February 9, 2018 at the Scugog Community Recreational Centre.

2. Background

- 2.1 DAAC and DEAC provide advice to staff and Regional Council on matters related to the environment and agriculture respectively. Additionally, the Committees are responsible for facilitating and participating in education and outreach activities.
- 2.2 Since their inception, DAAC and DEAC have hosted various joint workshops and symposiums, with the last held in 2009. The 2018 workplans for both Committees identify continuing the working relationship between them as a priority.

3. DAAC-DEAC-DRRCC Climate Change Symposium

- 3.1 Over the summer of 2017, DEAC and DAAC began planning a Symposium on an issue of shared interest, climate change. The goal of the Symposium is to explore the linkages between the environment and agriculture under the common theme of climate change.
- 3.2 The Durham Region Roundtable on Climate Change was invited to partner and has provided both financial and in-kind support for the event.
- 3.3 The Symposium will be held on February 9 from 8:30 a.m. to 3 p.m. at the Scugog Community Recreation Centre, (see Attachment #1).
- 3.4 Speakers for the day include a keynote by James Nowlan, Director of the Climate Change Policy Branch at the Ministry of the Environment and Climate Change, and representatives from conservation authorities, municipalities, and the agricultural sector, (the agenda for the day is provided in Attachment #2).
- 3.5 All members of Regional Council are invited to attend the Symposium as well as local councillors, staff from area municipalities, municipal advisory committee members (regional and area municipal), representatives from various provincial ministries, and other key stakeholders, including MPs and MPPs.

Fannibal Fest Film Tour – November 2, 2017

Report:

1. Purpose

- 1.1 The purpose of this report is to advise Council of the "Fannibal Fest Film Tour" that took place in Durham on November 2, 2017. This was Durham's first film tourism initiative.
- 1.2 The event consisted of a one-day bus tour that took fans of the television series, "Hannibal" to locations in Durham where scenes from the show were filmed. The tour took place in conjunction with the inaugural five-day North American Hannibal Convention, held in Toronto.

2. Background

- 2.1 Last spring, Film Durham was approached by the U.S.-based Fannibal Fest Committee to create a bus tour for Hannibal fans, to allow them to visit the sites that were used for filming the Hannibal television series from 2013 to 2015.
- 2.1 This sold out tour took the Hannibal fans to seven locations in Pickering, Ajax, Oshawa and Uxbridge. Although there were more locations that could have been included, the one-day timeframe was not sufficient to accommodate them all. A copy of the program guide, and a map showing the location of the seven sites, are

attached as Attachments 1 and 2 respectively.

- 2.2 During the tour, the group was able to re-enact scenes from various episodes, interact with location representatives about how the actual filming took place, and take photos of their favourite sites.
- 2.3 There were 54 participants in attendance from Canada, U.S.A., Ireland, Germany, Japan and Czech Republic. Most of them learned about the event through social media.
- 2.4 All tour participants enjoyed the event and 71 per cent agreed to be contacted about future Fannibal Fest bus tours, Durham Region Tourism, and Central Counties Tourism events.
- 2.5 The economic impact from this tour was approximately \$30,000.

3. Conclusion

- 3.1 It is anticipated the Fannibal Fest Film Bus Tour will become an annual event which provides opportunities for increased attendance, hotel bookings and visits to the Region's other amenities and tourist attractions.
- 3.2 The Fannibal Fest Film Tour created an opportunity to showcase Durham Region internationally through this film tourism event. Globally, film tourism is becoming more popular, with an estimated 100 million tourists world-wide seeking to visit film location sites each year. Similar tours will be considered for other productions filmed in Durham as a way of further growing the film sector in Durham Region.



1. Purpose

1.1 To provide information about the Association of Local Public Health Agencies' (alPHa) policy priorities.

2. Background

- 2.1 On December 8, 2017, alPHa released its <u>policy priorities</u> in anticipation of the 2018 Ontario general election.
- 2.2 alPHa sent its policy priorities to Ontario's political party leaders, health critics, the Minister of Health and Long-Term Care and the Attorney General.
- 2.3 Specific asks to the province have been made regarding the following public health issues:
 - Tobacco endgame;
 - Oral health for adults;
 - Universal pharmacare;
 - Cannabis legalization; and
 - Opioids strategy.
- 2.4 The goal of sharing alPHa's policy priorities is to raise awareness of these public health priority actions to help inform party policies and platforms in the months leading up to the election.

Boards of health are required to "superintend, provide or ensure the provision of the health programs and services required by the [Health Protection and Promotion] Act and the regulations to the persons who reside in the health unit served by the board" (section 4, clause a, HPPA). In addition, medical officers of health are required to "[report] directly to the board of health on issues relating to public health concerns and to public health programs and services under this or any other Act" (sub-section 67.(1), HPPA).

Accordingly, the Health Information Update is a component of the Health Department's 'Accountability Framework', which also may include program and other reports, Health Plans, Quality Enhancement Plans, Durham Health Check-Ups, Performance Reports, business plans and budgets; provincial performance indicators and targets, monitoring, compliance audits and assessments; RDPS certification; and accreditation by Accreditation Canada.

Proposed Changes to the Cannabis Act (Bill C-45)

The Board of Health of the Windsor-Essex County Health Unit would like to commend the Ministry of Health and Long-Term Care, Ministry of the Attorney General's office, and the Ministry of Finance for the proposed changes to the *Cannabis Act (Bill C-45)*. The increase in minimum age of consumers, restriction of cannabis to youth under the age of 19, the government-run LCBO model for retail outlets and plans to regulate the location of cannabis retail outlets through zoning and licensing, will help to mitigate the unintended consequences of legalization to vulnerable populations.

Consuming cannabis, especially on a regular basis, is associated with many adverse health outcomes. Chronic diseases related to the carcinogens, toxins, and irritants similar to those found in tobacco smoke are also associated with cannabis use (SHAF, 2016). The effects of cannabis are particularly detrimental to adolescents and youth under the age of 25, as the developing brain is likely to be affected. In addition, individuals with mental illness are seven times more likely to use cannabis weekly, and are ten times more likely to have a cannabis use disorder (CAMH, 2013). Cannabis use can also make mental illness worse.

Another public health concern related to cannabis legalization is drug-impaired driving. The effects associated with cannabis use, such as slowed reaction time, the impacts on decision-making and divided attention, makes driving extremely dangerous after cannabis use. Cannabinoids are, in fact, among the most common psychoactive substances found in deceased and injured drivers in Canada (Wettlaufer et al., 2017).

On October 19, 2017, the Board of Health of the Windsor-Essex County Health Unit passed a Resolution with regard to the licensing, planning, and zoning regulations of cannabis retail outlets and the coordinated efforts of Windsor-Essex municipalities in preventing the harms associated with cannabis use, as outlined below:

<u>Whereas</u> the federal government has announced its intention to legalize recreational cannabis through the passing of the *Cannabis Act* prior to July 1st, 2018, and

<u>Whereas</u> cannabis smoke contains many of the same carcinogens, toxins, and irritants found in tobacco smoke with the added psychoactive properties of cannabinoids like THC, and

Whereas increased access to cannabis will result in increased risk for chronic disease, mental illness and injury, and

<u>Whereas</u> municipalities have control over the density and location of retail outlets through zoning, planning, and licensing regulations,

<u>Now Therefore it be Resolved</u> that the Windsor-Essex County Board of Health for the Windsor-Essex County Health Unit encourages all Windsor-Essex municipalities to develop strict licensing, planning, and zoning regulations related to the location and density of cannabis retail outlets, particularly in areas where vulnerable populations may be unfairly targeted.

<u>Further that</u> staff of the Windsor-Essex County Health Unit work with enforcement agencies and municipalities to provide a public health perspective into decision making related to the enforcement of cannabis smoking in prohibited areas, and

<u>Further that</u> staff of the Windsor-Essex County Health Unit utilize the Lower-risk Cannabis Use Guidelines set out by key national stakeholders, like the Centre for Addictions and Mental Health and the Canadian Public Health Association, in the development of a comprehensive public education and awareness campaign.

The Board of Health at the Windsor-Essex County Health Unit supports the efforts aimed at keeping recreational cannabis out of the hands of children and youth, as well as other vulnerable populations to which harm may result.

Determining the locations of cannabis retail outlets in Windsor-Essex based on licensing, planning, and zoning regulations through a coordinated effort of the municipalities in Windsor-Essex, will help to ensure these populations are better protected from the negative effects of cannabis use. Additionally, in order to ensure local enforcement and health promotion goals can be met, the local Board of Health requires supplementary funding which can be allocated to the training and hiring of enforcement officers, health promotion staff, and administrative supports.

Dear Mayors and members of council,

We are writing to you today because we believe that the concerns of small business must be taken seriously by governments at every level, including the Municipal level. We are also concerned about the tax changes proposed by the federal Liberal government this past summer.

We are extremely concerned about the manner of the announcement, the short consultation period and the possible negative effects on Farmers, and Farm Families in our communities.

We are very aware of the unfairness of the current tax system, and we do encourage a system of tax fairness to address rising inequalities in Canada, however the decision by government to launch a consultation process in the middle of summer limited the capacity of Canadians, especially our local farmers, to fully participate.

Family farms represent a particular kind of small business, and differ from other small businesses. MP Guy Caron, tabled Bill C-274 during the 42nd parliament and the aim of this Bill was to facilitate the transfer of small businesses, or farm and fishing businesses, between family members by modifying the Income Tax Act. Sadly, this initiative was rejected by the Liberals during second reading.

Today's government announcement of a reduced small business tax is good news. However, we remain concerned and uncertain of what is coming next.

We are asking you to write to the Minister of Finance and to continue to pressure the government to honour its campaign promises and focus on real tax fairness.
