Report:

1. Purpose

1.1 The purpose of this report is to provide an overview of Smart Commute Durham's progress for 2019 and the 2020 Workplan.


2. Background

- 2.1 The Smart Commute program is an initiative of cities and regions of the Greater Toronto and Hamilton Area (GTHA) to reduce traffic congestion and take action on climate change through the promotion of sustainable modes of transportation.
- 2.2 Since the Smart Commute Durham (SCD) program was established in 2008, it has grown from 3 to 31 members consisting of 45,142 employees across Durham Region, which equates to 22% of Durham employees¹ (refer to Smart Commute Employer Members and Employee Members charts below). The program has

achieved an average yearly reduction of 386,961 vehicles kilometres travelled (VKT), 21,623 single occupancy vehicle (SOV) and 86.2 metric tonnes of GHG reductions², which is equivalent to 210,758 miles driven by an average passenger vehicle.³

2.3 For 2020 the Smart Commute Durham program aims to grow its membership to include 5 hospital sites across Durham Region that consist of approximately 8,980 staff.⁴



- 2.4 An important part of the SCD program is supporting programming and initiatives to promote and encourage sustainable modes of transportation for commuting purposes. The operating model for the program involves working with employees to promote sustainable commuter options, such as carpooling, transit, cycling, walking, telework, and flexible work arrangements.
- 2.5 SCD's operating model involves the creation and implementation of an annual workplan. The progress report from 2019 and the description of the activities that SCD plans to provide in year of 2020 is summarized below.
- 2.6 In 2019, SCD staff facilitated several activities, including the successful implementation of sustainable commuter programs, events and campaigns, which can be classified under the following categories:

- a. Outreach and Education
 - Bike Month multiple events were held at Smart Commute businesses including bike tours, bike repair workshops, and educational sessions on bike safety for all road users. Bike Month is an awareness campaign which aims to encourage cycling and active transportation as well as educate all road users on cycling safety. Bike Month initiatives also help support the goals and objectives identified in various Regional policies including the Official Plan, Transportation Master Plan, the Vision Zero Strategic Road Safety Action Plan, and helps support the achievement of the overall Transportation Demand Management (TDM) targets⁵ for the Region.
 - **OPG Darlington** Regional staff began working with OPG Darlington to implement targeted programming at the worksite. In 2019, staff conducted a site visit and prepared a draft survey intended to establish an understanding of the commuting habits of Darlington employees. This new relationship with OPG Darlington has increased outreach of SCD by appropriately 3,100 employees. For 2020, staff will continue to work with the Darlington Smart Commute champions to determine appropriate programming for the worksite.
- b. Communication and Marketing
 - Regional staff created communications and marketing materials for Smart Commute Month and Winter Commute Month.
 - Regional staff maintained consistent lines of communication with Smart Commute members, providing them with the necessary updates and information as program changes occurred.
- c. Monitoring and Evaluation
 - Regional staff conducted quarterly surveys to examine commuting behaviours across Durham Region to inform future activities and determine priorities for SCD program. Quarterly surveys consisted of three brief surveys and a longer, more in-depth survey carried out in September in conjunction with Smart Commute Month.

- These surveys revealed that the majority of respondents (83%) drive alone to and from work and there is an upward trend between the number of people who carpool to and from work between Q2 and Q4 of 2019 with 22% of program participants indicating that they carpool to and from work; and a 2% increase in carpooling each quarter.
- The survey findings complement the goals identified in Section 5.5.1 of the <u>Envision Durham Transportation Discussion Paper</u>, part of the Municipal Comprehensive Review of the Region's Official Plan, which notes the importance of reducing single-occupant vehicle travel and reduce peak period travel.
- These results have been used to tailor SCD programming efforts and work with Durham Region organizations to develop strategies and initiatives to reduce single-occupant vehicle travel and increase sustainable commuting by promoting the Smart Commute Ride Matching Tool, encouraging transit use for first and last mile of trips, and promoting active transportation events and campaigns such as cycling and steps challenges.
- 2.7 Following the decision by Metrolinx in June 2019 to discontinue the Smart Commute Program funding, Regional staff worked with the other GTHA regional partners (the Regions of Peel, York and Cities of Toronto and Hamilton) to draft a Memorandum of Understanding (MOU) between the Regional and Municipal partners to redefine the role of Smart Commute and establish a path forward. Regional staff will continue to work with the GTHA regional partners to update the Smart Commute website and finalize the MOU, which will be presented to Council for approval in Q2/Q3 of 2020.

3. 2020 Workplan

- 3.1 The SCD commuter activities include sustainable commuter programs, events and campaigns. The SCD initiatives planned for 2020 fall under four key categories:
 - a. Programs Campaigns and Events
 - Programs, campaigns and events make up the majority of SCD initiatives for 2020 and are a critical component of SCD to help encourage more people to use sustainable modes of transportation to get to and from work.

- b. Promotion and Outreach
 - Promotion and outreach are essential components of SCD to help promote and generate awareness and increase our membership.
- c. Funding and Resource Support
 - It is important to continue to support new and existing initiatives to successfully continue to promote, support and implement the various events and components of SCD.
- d. Monitoring and Evaluation
 - Monitoring and evaluation are important components of SCD to help ensure initiatives, and members are achieving their outcomes, to help improve existing and new programs / members experience and continue to operate smoothly.

4. Conclusion

4.1 Smart Commute Durham is a key component of the Region's Transportation Demand Management (TDM) efforts and forms a part of the Durham Transportation Master Plan. Commuters can continue to look to the Region of Durham when it comes to sustainable transportation options as it transitions to new programming over the coming year.

Application to amend the Durham Regional Official Plan, submitted by Darmar Farms Inc. to permit the severance of a dwelling rendered surplus to a farming operation as a result of the consolidation of non-abutting farm parcels, in the Township of Brock, File: OPA 2020-001.

Recommendation:

That the Planning and Economic Development Committee recommends:

- A) That Commissioner's Report #2020-P-** be received for information; and
- B) That all submissions received be referred to the Planning Division for consideration.

Report:

1. Purpose

1.1 On February 3, 2020, Clark Consulting Services Ltd., on behalf of Darmar Farms Inc. submitted an application to amend the Regional Official Plan (ROP) to permit the severance of a dwelling rendered surplus as a result of the consolidation of nonabutting farm parcels in the Township of Brock. 1.2 A "Notice of Complete Application and Public Meeting" regarding the application has been advertised in The Brock Citizen and Kawartha Lakes This Week newspapers. Notice of this meeting has also been mailed to those who own land within 120 metres (400 feet) of the subject site. The report was made available to the public prior to the meeting.

2. Site Description

- 2.1 The subject site is located at 396 Cameron Street East and is located immediately east of the Cannington urban area (Attachment 1).
- 2.2 The applicant is a private farm corporation which owns a total of 13 agricultural parcels under the name Darmar Farms, that encompasses approximately 579.5 hectares (1,432 acres). Four of the parcels are located in Durham Region (Attachment 2).
- 2.3 The agricultural parcel is triangular in shape and contains an existing dwelling. A watercourse traverses the property from west to east.
- 2.4 Surrounding uses located adjacent to the subject site include:
 - a. North Beaver River Wetlands Trail (part of a former railway line now owned by Hydro One), agricultural lands;
 - b. East rural residential lands, agricultural lands, Simcoe Street;
 - c. South rural residential lands, agricultural lands; and
 - d. West rural residential lands, Cannington urban area, sewage lagoons.
- 2.5 The proposed amendment to the ROP would permit the severance of a 0.4 hectare (1 acre) parcel of land containing a farm dwelling from a 22.6 hectares (55.9 acre) agricultural parcel. The dwelling is not utilized by a farm employee and is currently rented. The retained agricultural parcel will continue to be used for agricultural purposes.

3. Reports Submitted in Support of the Application

3.1 A Planning Justification Report prepared by Clark Consulting Services Ltd. has been submitted in support of the application. The report concludes that the proposed amendment meets the objectives and requirements of the Provincial Policy Statement, the Greenbelt Plan and the ROP. The report also concludes the proposed severance will comply with Minimum Distance Separation (MDS) requirements.

- 3.2 A Farm Holdings Inventory Report prepared by Clark Consulting Services Ltd. indicates that Darmar Farms Inc. owns four farms in the Region of Durham. These farms are used for cash cropping. Darmar Farms owns two houses within the Region, both of which are surplus to the farming operation.
- 3.3 A Site Screening Questionnaire completed by GHD indicated that there are no significant site contamination concerns on the subject property.

4. Provincial Plans and Policies

4.1 The subject site is located within the "Protected Countryside" designation of the Greenbelt Plan. The Provincial Policy Statement, as well as the Greenbelt Plan may permit the severance of a residence surplus to a farming operation as a result of farm consolidation. Severances of surplus farm dwellings are allowed provided the planning authority ensures that a residential dwelling is not permitted in the future on the proposed retained farm lot created by the severance.

5. Durham Regional Official Plan Context

- 5.1 The subject site is designated "Prime Agricultural Areas" in the ROP with a Key Hydrologic Feature (watercourse) on site. Severance applications for agricultural uses may be considered in accordance with the relevant policies of Sub-Section 9A of the ROP.
- 5.2 Policy 9A.2.10 of the ROP permits the severance of a farm dwelling rendered surplus as a result of a farmer acquiring a non-abutting farm, provided that:
 - a. The dwelling is not needed for a farm employee;
 - b. The farm parcel is a size which is viable for farm operations;
 - c. For sites within the Protected Countryside of the Greenbelt Plan, the dwelling was in existence as of December 16, 2004;
 - d. The farm parcel is zoned to prohibit any further severances or the establishment of any residential dwelling.

6. Consultation

6.1 The ROP Amendment has been circulated to a variety of agencies, including the Ministry of Municipal Affairs and Housing; the Township of Brock; the City of

Kawartha Lakes; the Regional Health Department; Lake Simcoe Region Conservation Authority; and the Durham Agricultural Advisory Committee.

7. Public Consultation

- 7.1 Anyone who attends the public meeting may present an oral submission, and/or provide a written submission to the Planning and Economic Development Committee on the proposed amendment. Also, any person may make written submissions at any time before Regional Council makes a decision.
- 7.2 If a person or public body does not make oral submissions at a public meeting or does not make written submissions before the proposed official plan amendment is adopted, the person or public body:
 - a. Is not entitled to appeal the decision of the Region of Durham to the Local Planning Area Tribunal (LPAT) (formerly the Ontario Municipal Board); and
 - b. May not be added as a party to the hearing of an appeal before the LPAT, as appropriate, unless in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
- 7.3 Anyone who want to be notified of Regional Council's decision on the proposed ROP Amendment must submit a written request to:

8. Future Regional Council Decision

- 8.1 The Planning and Economic Development Committee will consider the proposed ROP Amendment at a future meeting and will make a recommendation to Regional Council. Council's decision will be final unless appealed.
- 8.2 All persons who make oral submissions, or have requested notification in writing, will be given notice of the future meeting of the Planning and Economic Development Committee and Regional Council at which the subject application will be considered.





Application to amend the Durham Regional Official Plan, submitted by D.S. & B. Farms Inc. to permit a severance of a dwelling rendered surplus to a farming operation as a result of a consolidation of non-abutting farm parcels, in the Township of Brock, File: OPA 2020-002.

Recommendation:

That the Planning and Economic Development Committee recommends:

- A) That Commissioner's Report #2020-P-** be received for information; and
- B) That all submissions received be referred to the Planning Division for consideration.

Report:

1. Purpose

1.1 On January 30, 2020, Clark Consulting Services Ltd., on behalf of D.S. & B. Farms Inc. submitted an application to amend the Regional Official Plan (ROP) to permit the severance of a dwelling rendered surplus as a result of the consolidation of non-abutting farm parcels in the Township of Brock. 1.2 A "Notice of Complete Application and Public Meeting" regarding the application has been advertised in The Brock Citizen newspaper. Notice of this meeting has also been mailed to those who own land within 120 metres (400 feet) of the subject site. The report was made available to the public prior to the meeting.

2. Site Description

- 2.1 The subject site is located at C1565 Concession Road 1, in the former Township of Thorah (Attachment 1).
- 2.2 The applicant is a private farm corporation which owns a total of 11 parcels under the name D.S. & B. Farms Inc. that encompasses approximately 557 hectares (1,376 acres). Seven parcels are located in the Durham Region (Attachment 2).
- 2.3 The subject site is generally rectangular in shape, and has access to Concession Road 1. It is approximately 44.33 hectares (109.54 acres) in size, of which approximate 30 hectares (74.13 acres) is being used for cultivation. A woodland is located on the northwest portion of the site, while a watercourse (the Beaver River) traverses the eastern parts of the site. The subject lands are generally flat. A residential dwelling with small accessory structures (sheds) are located on the southern part of the site.
- 2.4 Surrounding uses located adjacent to the subject site include:
 - a. North agricultural lands, woodlands and wetlands;
 - b. East agricultural lands, Beaver River, woodlands and wetlands;
 - c. South agricultural lands; and
 - d. West agricultural lands, woodlands and wetlands.
- 2.5 The proposed amendment to the ROP would permit the severance of a 0.93 hectare (2.3 acre) parcel of land containing a farm dwelling from a 43.4 hectare (107.24 acre) agricultural parcel. The dwelling is not utilized by a farm employee. The retained agricultural parcel will continue to be used for agricultural purposes.

3. Reports Submitted in Support of the Application

3.1 A Planning Justification Report prepared by Clark Consulting Services Ltd. has been submitted in support of the application. The report concludes that the proposed amendment meets the objectives and requirements of the Provincial Policy Statement, the Greenbelt Plan and the ROP. The report also concludes the proposed severance will comply with Minimum Distance Separation (MDS) requirements.

3.2 A Farm Holding Inventory Report prepared by Clark Consulting Services Ltd. indicates that D.S. & B. Farms Inc. owns seven farms in the Durham Region and four farms in the City of Kawartha Lakes. These farms are used for cash cropping. There are two dwellings located on the farm properties within the Region.

4. Provincial Plans and Polices

4.1 The subject site is located within the "Protected Countryside" designation of the Greenbelt Plan. The Provincial Policy Statement, as well as the Greenbelt Plan may permit the severance of a residence surplus to a farming operation as a result of farm consolidation. Severances of surplus farm dwellings are allowed provided the planning authority ensures that a residential dwelling is not permitted in the future on the proposed retained farm lot created by the severance.

5. Durham Regional Official Plan Context

- 5.1 The subject site is designated "Prime Agricultural Areas" in the ROP with portions of the site containing Key Natural Heritage and/or Hydrological Features (KNHHF). Severance applications for agricultural uses may be considered in accordance with the relevant policies of Sub-Section 9A of the ROP.
- 5.2 Policy 9A.2.10 of the ROP permits the severance of a farm dwelling rendered surplus as a result of a farmer acquiring a non-abutting farm, provided that:
 - a. The dwelling is not needed for a farm employee;
 - b. The farm parcel is a size which is viable for farm operations;
 - c. For sites within the Protected Countryside of the Greenbelt Plan, the dwelling was in existence as of December 16, 2004;
 - d. The farm parcel is zoned to prohibit any further severances or the establishment of any residential dwelling.

6. Consultation

6.1 The ROP Amendment has been circulated to a variety of agencies, including the Ministry of Municipal Affairs and Housing; the Township of Brock; the City of

Kawartha Lakes; the Regional Health Department; Lake Simcoe Region Conservation Authority; and the Durham Agricultural Advisory Committee.

7. Public Consultation

- 7.1 Anyone who attends the public meeting may present an oral submission, and/or provide a written submission to the Planning and Economic Development Committee on the proposed amendment. Also, any person may make written submissions at any time before Regional Council makes a decision.
- 7.2 If a person or public body does not make oral submissions at a public meeting or does not make written submissions before the proposed official plan amendment is adopted, the person or public body:
 - a. Is not entitled to appeal the decision of the Region of Durham to the Local Planning Area Tribunal (LPAT) (formerly the Ontario Municipal Board); and
 - b. May not be added as a party to the hearing of an appeal before the LPAT, as appropriate, unless in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
- 7.3 Anyone who want to be notified of Regional Council's decision on the proposed ROP Amendment must submit a written request to:

8. Future Regional Council Decision

- 8.1 The Planning and Economic Development Committee will consider the proposed ROP Amendment at a future meeting and will make a recommendation to Regional Council. Council's decision will be final unless appealed.
- 8.2 All persons who make oral submissions, or have requested notification in writing, will be given notice of the future meeting of the Planning and Economic Development Committee and Regional Council at which the subject application will be considered.





On behalf of Mayor Gary McNamara and Town Council, I am writing to advise that at its meeting on November 12, 2019, Tecumseh Town Council passed the following resolution:

Whereas the calls for service for 911 Misdials have risen dramatically in recent years, correlated with the rise in cell phone use; and

Whereas 911 Misdials must be responded to as if they were legitimate emergency calls; and

Whereas each 911 call is responded to with two OPP officers at an average time per call of 1.2 hours; and

Whereas each 911 call is a billable call to the municipality; and

Whereas in 2019 alone to date, 911 Misdials in Tecumseh number 1,082 calls, which is 28.8% of all billable calls for service to date; and

Whereas 911 Misdials are not unique to Tecumseh and in fact are common across the Province at an estimated cost of millions of dollars;

Now Therefore Be It Resolved That the Municipal, Federal and Provincial governments and relevant associations, including but not limited to, the Ontario Association of Police Services Boards (OAPSB), the Ontario Association of Chiefs of Police (OACP), the Federation of Canadian Municipalities (FCM) and the Association of Municipalities of Ontario (AMO), be requested to lobby the telecommunications industry and smart phone manufacturers to develop a solution to 911 Misdials.

Re: Item for Discussion – Motion of Support for Ban of Single-Use Disposable Wipes

At its meeting of January 23, 2020, the Council of the Corporation of the Town of Bracebridge ratified motion 20-GC-032/033, regarding the support for ban of single-use disposable wipes, as follows:

"WHEREAS Single-use wipes are a \$6 billion industry and growing, and are now being advertised as a clean alternative to toilet paper that is safe to flush;

AND WHEREAS Single-use wipes accumulate in the sewer system and eventually clog the sanitary sewer system, requiring significant additional repair and maintenance;

AND WHEREAS the Municipal Enforcement Sewer Use Group (MESUG) estimates nonflushable materials cause \$250 million in annual repairs across Canada;

AND WHEREAS a 2019 study released by Ryerson University tested 101 types of single-use disposable wipes and found that all of the wipes failed basic requirements of flushable products;

AND WHEREAS there is no one standard for what the word "flushable" means;

AND WHEREAS there is a lack of public awareness of the impact caused by non-flushable wipes being flushed down toilets and consumer education and outreach could play a large part in reducing the impact;

AND WHEREAS Single-use wipes, even when properly disposed of as waste, are an inefficient and unsustainable use of resources that contribute significantly to environmental degradation.

NOW THEREFORE BE IT RESOLVED THAT the Town of Bracebridge lobby the Provincial and Federal Governments to ban single-use disposable wipes;

AND THAT this resolution be forwarded to the Right Honourable Prime Minister of Canada; the Honourable Premier of Ontario; the Minister of the Environment, Conservation and Parks; the Minister of Municipal Affairs and Housing; the Association of Municipalities of Ontario (AMO); the Local Members of Provincial Parliament; and all Municipalities in Ontario.

AND FURTHER THAT the District of Muskoka be requested to endorse the resolution and the ban on single-use wipes."


Municipalities play a key role in implementing provincial land use policies through local official plans, zoning by-laws and other planning decisions. The Planning Act requires that decisions on land use planning matters be "consistent with" PPS policies.

The PPS, 2020 supports implementation of More Homes, More Choice: Ontario's Housing Supply Action Plan and includes key changes to:

- Encourage an increase in the mix and supply of housing
- · Protect the environment and public safety
- Reduce barriers and costs for development and provide greater certainty
- Support rural, northern and Indigenous communities
- Support the economy and job creation

The PPS, 2020 works together with other recent changes to the land use planning system – including changes to the Planning Act through Bill 108. More Homes, More Choice Act, 2019 and A Place to Grow: Growth Plan for the Greater Golden Horseshoe. Collectively, these changes support key government priorities of increasing housing supply, supporting job creation and reducing red tape – while continuing to protect Ontarians' health and safety and the environment, including the Greenbelt.

The PPS, 2020 policies will take effect on May 1, 2020. It will replace the Provincial Policy Statement, 2014. In accordance with section 3 of the Planning Act, all decisions affecting land use planning matters made after this date shall be consistent with the PPS, 2020. My ministry will be in touch to provide education and training for municipal staff to support implementation of the new policies.

P. Veiga responded to questions from the Committee regarding the processing of different materials; whether all waste management vehicles are

retrofitted with both recycling streams (paper products/plastic products); whether there are mandatory compost requirements in Durham Region; how apartment and condominium buildings are serviced; how Extended Producer Responsibility will affect Durham Region and when does it start; and the partnership between York Region and Durham Region regarding the DYEC.

6. Items for Discussion/Input

A) Update from Climate Change Resiliency Homeowner's Guide Subcommittee

J. Cuthbertson advised that the Climate Change Resiliency Homeowner's Guide Subcommittee met before the meeting and had a good discussion with several submissions for different sections of the guide such as water and transportation. He noted that they also received feedback from Ian McVey, Manager of Sustainability.

B) Update from Environmental Awards Subcommittee

G. Layton advised that the Environmental Awards Subcommittee met with Ian McVey, Manager of Sustainability regarding whether the DRRCC would be interested in being a co-host for the Environmental Achievement Awards. She advised that I. McVey would bring that forward to the DRRCC for input.

G. Layton advised that many ideas were discussed such as a possible new venue, having family namesakes of the awards come and present the award, the option of a guest speaker, and whether there were any possible sponsors for the award ceremony.

A. Luqman will advise the Committee if any approvals are needed from Council regarding the selection of award recipients.

C) <u>Bee Pollinator Spring Seedling Distribution</u>

D. Upadhyay advised that he sent out emails to various seed distribution companies inquiring about costs. The Ontario Seed Company was the most reasonable price for buying in bulk. Discussion ensued regarding methods of distributing the seeds to residents such as handing it out at the annual compost distribution days. A. Luqman advised that she would look into how many residents attend the compost days. G. Layton advised that she would reach out to Richers Herbs to inquire about their prices and what they could offer. There was a further suggestion to cut the seed packets with clover to help save costs. The Committee estimated buying 2 kg of seed (roughly 400 packets) to distribute.

G. Carpentier advised that the Scugog Environmental Advisory Committee (SEAC) undertook their own pollinator project and that they purchased seed packets that came with instructions. He advised that he'd send A. Luqman

more information regarding the SEAC's project and what their final decision was.

J. Cuthberston and K. Murray advised that they would assist D. Upadhyay with this project.

D) Envision Durham Housing Policy Planning Discussion Paper

A. Luqman advised that the Envision Durham Housing Policy Planning Discussion Paper is the last paper of the ten-paper series. It is currently open for comment. She advised that comments could be submitted individually or on behalf of the DEAC.
