

Independent Auditors' Report

To the Candidate of the John Henry Campaign:

We have audited the accompanying Candidate Form 4 of the John Henry Political Campaign as at December 31, 2018.

Opinion

In our opinion, the Candidate Form 4 presents fairly, in all material respects, the financial position of the John Henry Campaign as at December 31, 2018 and the results of its operations and its cash flows for the period then ended in accordance with the Municipal Elections Act, 1996.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Company in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter – Basis of Accounting and Restriction on Distribution and Use

The Candidate Form 4 is prepared to assist the John Henry Political Campaign in complying with the financial reporting provisions of the Municipal Elections Act, 1996. As a result, the Candidate Form 4 may not be suitable for another purpose. Our report is intended solely for the John Henry Political Campaign, the office of the clerk of the Regional Municipality of Durham and the Ontario Ministry of Municipal Affairs. This report should not be distributed to or used by parties other than the John Henry Political Campaign, the office of the clerk of the Regional Municipality of Durham or the Ontario Ministry of Municipal Affairs. Our opinion is not modified in respect of this matter.

Management's Responsibility for the Candidate Form 4

Management is responsible for the preparation and fair presentation of the Candidate Form 4 in accordance with the Municipal Elections Act, 1996, and for such internal control as management determines is necessary to enable the preparation of the Candidate Form 4 that is free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on the Candidate Form 4 based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Candidate Form 4 is free from material misstatement.





Auditors' Responsibility (continued)

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Candidate Form 4. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the financial statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the Candidate Form 4 in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statement.
