2023 Budget Highlights

Housing and Homelessness

- Total investment of \$117.3 million an increase of 31% from 2022, including a Regional investment of \$75.5 million towards:
 - · Expanded homelessness support programs
 - The At Home Incentive Program to support the development of new affordable housing units
 - Rent supplement programs and community housing provider payments
 - · Redevelopment of social housing across the Region

Paramedic Services

- Total investment of **\$76.3 million** an **increase of 16%** from 2022 including:
 - 48 hours of new paramedic service daily, to be deployed at peak hours with four additional ambulances and 24 new paramedics
 - Advanced Care Paramedic training
 - Capital investments for the Clarington Station, a North Durham Station and a new station in South Whitby

- Total investment of \$199.2 million including:
 - 27,178 additional service hours



- Plans to construct a new Regional long-term care home in North Pickering
- Ongoing public health supports for COVID-19 pandemic
- Support for Ukrainian newcomers in Durham
- \$183.3 million in roads and bridges capital infrastructure program
- Implement the Region's Cycling Plan including 19.5 kms of cycling infrastructure
- Expand Durham Vision Zero, the Region's plan to improve road safety
- Prepare for impacts from Bill 23, *More Homes Built Faster Act, 2022*
- Advance the implementation of the Region's Corporate Climate Action Plan and Durham Community Energy Plan
- Advance deep energy retrofits at Regional facilities

- Implement Ready Set Future A PLACE Blueprint for Durham, the Region's Economic Development and Tourism Strategy

2023 Regional Services (excluding water supply and sanitary sewerage services)

Property taxation is the single largest source of funding for the Region, averaging approximately 42 per cent of the annual funding required for the full scope of regional services excluding water supply and sanitary sewerage services. Other sources of funding include federal and provincial funding, development charges, reserves/reserve funds, and debt financing. The graph below provides a breakdown of the Regional portion of the 2023 property tax bill which supports a wide range of programs and services for a growing and diverse community of residents and businesses.
