

By-law Number 2025-042
of The Regional Municipality of Durham

Being a by-law to authorize the borrowing upon sinking fund debentures in the principal amounts authorized by by-laws Numbers 2025-039, 2025-040 and 2025-041 in the aggregate principal amount of \$140,000,000.00 (of which amount an aggregate principal amount not exceeding \$75,189,978.47 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date) and the issuing of one series of sinking fund debentures therefor.

Whereas the *Municipal Act, 2001*, as amended (the “Act”) provides that a municipality may incur a debt for municipal purposes, whether by borrowing money or in any other way, and may issue debentures and prescribed financial instruments and enter prescribed financial agreements for or in relation to the debt;

And Whereas clause of 408 (4)(a) of the Act provides that a debenture by-law shall provide for raising in each year as part of the general upper-tier levy the amounts of principal and interest payable in each year under the by-law to the extent that the amounts have not been provided for by other taxes or by fees or charges imposed on persons or property by a by-law of any municipality and clause 408 (4)(b) provides that a debenture by-law shall include a provision that contemplates the repayment of the principal in annual instalments and payment of the interest on the unpaid balance in one or more instalments in each year. Subsection 408 (5) of the Act further provides that the total amount of principal and interest that must be raised in a year under clause of 408 (4)(a) of the Act does not include any outstanding amount of principal specified as payable on the maturity date of a debenture if one or more refinancing debentures are issued by the municipality on or before the maturity date in respect of the outstanding principal;

AND WHEREAS clause 409 (1)(a) of the Act provides that a municipality may provide in a debenture by-law that all or a portion of the debentures are sinking fund debentures which have the principal payable on a fixed date and paragraph 1 of subsection 409 (2) of the Act provides that a by-law passed under section 409 of the Act shall provide for an estimated amount in each year for the sinking fund which, with interest compounded annually, will be sufficient to pay the principal of the debentures at maturity. Subsection 409 (3) of the Act provides that an amount required to be provided in a year under subsection 409 (2) of the Act shall be deemed to be an amount of principal payable to the lender in the year for the purposes of clause of 408 (4)(a) of the Act (as well as of other subsections of the Act);

And Whereas the Act provides that if a municipality intends to incur debt for two or more purposes, or if it has passed separate debenture by-laws authorizing borrowing for two or more purposes but has not sold any of the debentures, the municipality may by by-law provide for the issue of one series of debentures for the debt;

And Whereas the Council of The Regional Municipality of Durham (the “Upper-tier Municipality”) has passed debenture by-laws as follows:

(1)By-law Number 2025-039: to authorize the borrowing upon 10 year sinking fund debentures in the principal amount of \$47,750,000.00 (of which amount a principal amount not exceeding \$25,645,153.37 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date) for a capital work of The Corporation of the Municipality of Clarington;

(2)By-law Number 2025-040: to authorize the borrowing upon 10 year sinking fund debentures in the principal amount of \$24,889,000.00 (of which amount an aggregate

principal amount not exceeding \$13,367,166.96 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date) for a capital work of The Corporation of the City of Pickering; and

(3)By-law Number 2025-041: to authorize the borrowing upon 10 year sinking fund debentures in the principal amount of \$67,361,000.00 (of which amount a principal amount not exceeding \$36,177,658.14 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date) for a capital work of the Upper-tier Municipality;

all of which by-laws are hereinafter referred to as the “Debenture By-laws”;

And Whereas the Act also provides that all debentures issued under a by-law passed by a regional municipality for its own purposes are direct, joint and several obligations of the regional municipality and its lower-tier municipalities;

And Whereas the Act also provides that a municipality shall authorize long-term borrowing by the issue of debentures or through another municipality under section 403 or 404 of the Act and subsection 403 (7) of the Act provides that all debentures issued under a by-law passed by an upper-tier municipality under section 403 of the Act are direct, joint and several obligations of the upper-tier municipality and its lower-tier municipalities;

And Whereas subsection 408 (2.1) of the Act provides that a municipality may issue a debenture or other financial instrument for long-term borrowing only to provide financing for a capital work;

And Whereas the total of the principal amounts authorized to be borrowed by the Debenture By-laws is the aggregate principal amount of \$140,000,000.00 (of which amount an aggregate principal amount not exceeding \$75,189,978.47 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date as follows: a principal amount not exceeding \$25,645,153.37 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date for the capital work of The Corporation of the Municipality of Clarington as described in Schedule “A” to By-law Number 2025-039, in consultation with The Corporation of the Municipality of Clarington, an aggregate principal amount not exceeding \$13,367,166.96 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date for the capital work of The Corporation of the City of Pickering as described in Schedule “A” to By-law Number 2025-040, in consultation with The Corporation of the City of Pickering and a principal amount not exceeding \$36,177,658.14 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date for the capital work of the Upper-tier Municipality as described in Schedule “A” to By-law Number 2025-041) and it is desirable to consolidate the said amounts into one aggregate principal amount of \$140,000,000.00 to be issued on October 31, 2025, and to be payable at the time and bearing interest as hereinafter set forth, as agreed to by the Upper-tier Municipality on October 16, 2025.

Now therefore, the Council of The Regional Municipality of Durham hereby enacts as follows:

1. That for the capital works described in the Debenture By-laws (the “Capital Works”), the borrowing upon the credit of the Upper-tier Municipality at large of the aggregate principal amount of \$140,000,000.00 (of which amount an aggregate principal amount not exceeding \$75,189,978.47 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date as follows: a principal amount not exceeding \$25,645,153.37 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date for the capital work of The Corporation of the Municipality of Clarington as described in Schedule “A” to By-law Number 2025-

039, in consultation with The Corporation of the Municipality of Clarington, an aggregate principal amount not exceeding \$13,367,166.96 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date for the capital work of The Corporation of the City of Pickering as described in Schedule "A" to By-law Number 2025-040, in consultation with The Corporation of the City of Pickering and a principal amount not exceeding \$36,177,658.14 may be raised by the issue of refinancing sinking fund debentures on or before the maturity date for the capital work of the Upper-tier Municipality as described in Schedule "A" to By-law Number 2025-041) as one series of 10 year sinking fund debentures and the issue of one series of sinking fund debentures therefor in minimum denominations of \$1,000.00, as hereinafter set forth are hereby authorized.

2. That the Regional Chair or the Acting Regional Chair, as the case may be, and the Regional Treasurer of the Upper-tier Municipality are hereby authorized to cause any number of sinking fund debentures in the aggregate principal amount of \$140,000,000.00, as described in section 1, above (the "Debentures") to be issued as one series of debentures, payable as to principal on October 31, 2035 with semi-annual instalments of interest thereon payable on April 30 and October 31, to be issued for such amounts of money as may be required for the Capital Works in global and definitive forms, not exceeding in total the said principal amount of \$140,000,000.00. The Debentures shall bear the Upper-tier Municipality's municipal seal and the signatures of the Regional Chair or the Acting Regional Chair, as the case may be, and of the Regional Treasurer of the Upper-tier Municipality, all in accordance with the provisions of the Act. The Debentures are sufficiently signed if they bear the required signatures and each person signing has the authority to do so on the date he or she signs. The Debentures shall initially be issued in global fully registered form as four certificates in the aggregate principal amount of \$140,000,000.00, substantially in the form attached as Schedule "A" hereto and forming part of this By-law (the "Global Debentures"). The Global Debentures shall initially be issued in the name of CDS & CO. as nominee of CDS Clearing and Depository Services Inc. ("CDS") and shall provide for payment of principal and interest electronically in final and irrevocable same-day funds in accordance with the applicable requirements of CDS, so long as the Global Debentures are held by CDS.
3. (1) That the Debentures shall all be dated the 31st day of October, 2025, and as to both principal and interest shall be expressed and be payable in lawful money of Canada. The Debentures shall be issued for a term of 10 years bearing interest at the rate of 3.75% per annum, and principal (with accrued interest) shall be payable on the 31st day of October, 2035. In each year during such period, interest on the Debentures shall be payable in semi-annual instalments of \$2,625,000.00 on each of April 30 and October 31. The amount of \$6,055,471.08 shall be deposited on or before October 31 (commencing on October 31, 2026) by the Regional Treasurer of the Upper-tier Municipality, or an authorized official of the Upper-tier Municipality, into a sinking fund (the "Sinking Fund"), which amount, with interest compounded annually, will be sufficient to pay at maturity (October 31, 2035) the principal of the Debentures, subject to the ability of the Upper-tier Municipality to issue refinancing sinking fund debentures for further term(s) of years up to but not exceeding 10 years for the Capital Work of the Upper-tier Municipality in accordance with By-law Number 2025-041, subject to subject to the ability of the Upper-tier Municipality to issue refinancing sinking fund debentures for further term(s) of years up to but not exceeding 10 years for the Capital Work of The Corporation of the Municipality of Clarington in accordance with By-law Number 2025-039 (in consultation with The

Corporation of the Municipality of Clarington) and subject to subject to the ability of the Upper-tier Municipality to issue refinancing sinking fund debentures for further term(s) of years up to but not exceeding 10 years for the Capital Work of The Corporation of the City of Pickering in accordance with By-law Number 2025-040 (in consultation with The Corporation of the City of Pickering), all in accordance with the Act.

(2) That of the principal amount of \$47,750,000.00 that matures in respect of the Debentures on October 31, 2035 for The Corporation of the Municipality of Clarington, a principal amount not exceeding the amount of \$25,645,153.37 payable thereunder may be raised by the issue of refinancing sinking fund debentures over further term(s) of years up to but not exceeding 10 years for the Capital Work of The Corporation of the Municipality of Clarington as described in Schedule "A" to By-law Number 2025-039 (20 years being the maximum period of years for the repayment of the debt for which such Debentures will be and the refinancing debentures may be issued), in consultation with The Corporation of the Municipality of Clarington.

(3) That of the principal amount of \$24,889,000.00 that matures in respect of the Debentures on October 31, 2035 for The Corporation of the City of Pickering, an aggregate principal amount not exceeding the amount of \$13,367,166.96 payable thereunder may be raised by the issue of refinancing sinking fund debentures over further term(s) of years up to but not exceeding 10 years for the Capital Work of The Corporation of the City of Pickering as described in Schedule "A" to By-law Number 2025-040 (20 years being the maximum period of years for the repayment of the debt for which such Debentures will be and the refinancing debentures may be issued), in consultation with The Corporation of the City of Pickering.

(4) That of the principal amount of \$67,361,000.00 that matures in respect of the Debentures on October 31, 2035 for the Upper-tier Municipality, a principal amount not exceeding the amount of \$36,177,658.14 payable thereunder may be raised by the issue of refinancing sinking fund debentures over further term(s) of years up to but not exceeding 10 years for the Capital Work of the Upper-tier Municipality as described in Schedule "A" to By-law Number 2025-041 (20 years being the maximum period of years for the repayment of the debt for which such Debentures will be and the refinancing debentures may be issued).

(5) That contributions to the Sinking Fund as well as principal of and interest on the Debentures shall be made only on a day on which banking institutions in Toronto, Ontario are not authorized or obligated by law or executive order to be closed (a "Business Day") and if any date for payment is not a Business Day, payment shall be made on the next following Business Day and no further interest shall be paid in respect of the delay in such payment.

4. That interest shall be payable to the date of maturity of the Debentures and on default shall be payable both before and after default and judgment. Any amounts payable by the Upper-tier Municipality as interest on overdue principal or interest in respect of the Debentures shall be paid out of current revenue. Whenever it is necessary to compute any amount of interest in respect of the Debentures for a period of less than one full year, other than with respect to regular interest payments, such interest shall be calculated on the basis of the actual number of days in the period and a year of 365 days or 366 days, if applicable.
5. That in limited circumstances (as agreed to by both the Upper-tier Municipality and CDS) the Global Debentures shall be exchangeable for certificated Debentures in definitive fully registered form in authorized denominations upon surrender of the

Global Debentures to the Regional Treasurer of the Upper-tier Municipality. The definitive Debentures shall aggregate the same principal amount as the principal outstanding balance of the Global Debentures as of the record date for such exchange in accordance with the provisions of the Global Debentures, shall bear the same interest rate and maturity date, shall bear all unmatured interest obligations and shall have the same benefits and be subject to the same terms and conditions as the Debentures (except insofar as they specifically relate to the Global Debentures). In issuing definitive Debentures no change shall be made in the amount which would otherwise be payable in each year under the Global Debentures. The definitive Debentures shall be in fully registered form, payable as to principal and outstanding interest in lawful money of Canada at maturity upon presentation and surrender thereof at any specified branch in Canada of the Upper-tier Municipality's bank designated in the definitive Debentures. Prior to maturity, the definitive Debentures shall be payable as to interest by cheque sent by mail to the registered addresses of the registered holders or, if authorized in writing, by electronic transfer.

6. (1) That in respect of the Debentures, interest shall be raised in each year during the currency of the Debentures as part of the general upper-tier levy and shall be payable in semi-annual instalments of \$2,625,000.00 on each of April 30 and October 31. There shall also be raised in each year during the said period as part of the general upper-tier levy, the amount of \$6,055,471.08 for deposit into the Sinking Fund on or before October 31 (commencing on October 31, 2026) for the payment at maturity (October 31, 2035) of the principal of the Debentures. In each such year, for the Capital Work, the said two amounts (the amount for interest and the amount for the contribution to the Sinking Fund) shall be raised as part of the general upper-tier levy to the extent that the amount(s) have not been provided for by any other available source including other taxes or fees or charges imposed on persons or property by a by-law of any municipality. The total amount payable for deposit into the Sinking Fund and interest that must be raised in each such year does not include any amount payable for deposit into the Sinking Fund for the refinancing debentures that the Upper-tier Municipality is authorized to issue in respect of the Debentures on or before the maturity date of the Debentures, in accordance with the provisions of this By-law and the Act.

(2) That without limiting the generality of the foregoing, the lower-tier municipalities that comprise the Upper-tier Municipality (individually a "Lower-tier Municipality", collectively the "Lower-tier Municipalities") shall pay in accordance with By-law Number 2025-041, The Corporation of the Municipality of Clarington shall pay to the Upper-tier Municipality in accordance with By-law Number 2025-039 and The Corporation of the City of Pickering shall pay to the Upper-tier Municipality in accordance with By-law Number 2025-040 the amounts payable for interest and the amounts payable for deposit into the Sinking Fund for the payment at maturity of the principal of the Debentures except that the total amount payable for deposit into the sinking fund and interest that must be raised in each year does not include any amount payable for deposit into the Sinking Fund for the refinancing sinking fund debentures that the Upper-tier Municipality is authorized to issue in respect of the Debentures on or before the maturity date of the Debentures, if any, in accordance with the provisions of this By-law and the Act. The Upper-tier Municipality shall pay to the registered holders of the Debentures the amounts payable in each year for interest and the amount of the principal of the Debentures payable at maturity by such entities as set out in the Debenture By-laws and the amounts to be raised by levy each year pursuant to the Debenture By-laws shall be raised and collected and such

amounts shall be applied to such amounts payable for interest and for deposit into the Sinking Fund in the respective year in respect of the Debentures to be issued under this By-law in accordance with the Debenture By-laws and the Act.

(3) That if any Lower-tier Municipality fails to make any payment or portion of it as provided in this By-law, such Lower-tier Municipality shall pay interest to the Upper-tier Municipality on the amount in default at the rate of 15% per annum, from the date the payment is due until it is made.

(4) That there shall be raised, pursuant to this by-law, in each year of the currency of the Debentures, as part of the general upper-tier levy, the amounts required to be paid to the Upper-tier Municipality in any previous year by any one or more of the Lower-tier Municipalities to the extent that the amounts have not been paid to the Upper-tier Municipality in accordance with this By-law and the Act.

7. That the Debentures may contain any provision for their registration thereof authorized by any statute relating to municipal debentures in force at the time of the issue thereof.
8. That the Upper-tier Municipality shall maintain a registry in respect of the Debentures in which shall be recorded the names and the addresses of the registered holders and particulars of the Debentures held by them respectively and in which particulars of the cancellations, exchanges, substitutions and transfers of Debentures may be recorded and the Upper-tier Municipality is authorized to use electronic, magnetic or other media for records of or related to the Debentures or for copies of them.
9. That the Upper-tier Municipality shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Upper-tier Municipality shall deem and treat registered holders of the Debentures, including the Global Debentures, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Upper-tier Municipality on the Debentures to the extent of the amount or amounts so paid. Where a Debenture is registered in more than one name, the principal of and interest from time to time payable on such Debenture shall be paid to or to the order of all the joint registered holders thereof, failing written instructions to the contrary from all such joint registered holders, and such payment shall constitute a valid discharge to the Upper-tier Municipality. In the case of the death of one or more joint registered holders, despite the foregoing provisions of this section, the principal of and interest on any Debentures registered in their names may be paid to the survivor or survivors of such holders and such payment shall constitute a valid discharge to the Upper-tier Municipality.
10. That the Debentures are transferable or exchangeable at the office of the Regional Treasurer of the Upper-tier Municipality upon presentation for such purpose accompanied by an instrument of transfer or exchange in a form approved by the Upper-tier Municipality and which form is in accordance with the prevailing Canadian transfer legislation and practices, executed by the registered holder thereof or such holder's duly authorized attorney or legal personal representative, whereupon and upon registration of such transfer or exchange and cancellation of the Debenture or Debentures presented, the Regional Chair and the Regional Treasurer shall issue and deliver a new Debenture or Debentures of an equal aggregate principal amount in any authorized denomination or denominations as directed by the transferor, in the case of a transfer or as directed by the registered holder in the case of an exchange.

11. That the Regional Chair and the Regional Treasurer shall issue and deliver new Debentures in exchange or substitution for Debentures outstanding on the registry with the same maturity date and of like form which have become mutilated, defaced, lost, subject to a mysterious or unexplainable disappearance, stolen, destroyed or dematerialized, provided that the applicant therefor shall have: (a) paid such costs as may have been incurred in connection therewith; (b) (in the case when a Debenture is mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized) furnished the Upper-tier Municipality with such evidence (including evidence as to the certificate number of the Debenture in question) and an indemnity in respect thereof satisfactory to the Upper-tier Municipality in its discretion; and (c) surrendered to the Upper-tier Municipality any mutilated or defaced Debenture in respect of which new Debentures are to be issued in substitution.
12. That the Debentures issued upon any registration of transfer or exchange or in substitution for any Debentures or part thereof shall carry all the rights to interest if any, accrued and unpaid which were carried by such Debentures or part thereof and shall be so dated and shall bear the same maturity date and, subject to the provisions of this By-law, shall be subject to the same terms and conditions as the Debentures in respect of which the transfer, exchange or substitution is effected.
13. That the cost of all transfers and exchanges, including the printing of authorized denominations of the new Debentures, shall be borne by the Upper-tier Municipality. When any of the Debentures are surrendered for transfer or exchange the Regional Treasurer of the Upper-tier Municipality shall: (a) in the case of an exchange, cancel and destroy the Debentures surrendered for exchange; (b) in the case of an exchange, certify the cancellation and destruction in the registry; (c) enter in the registry particulars of the new Debenture or Debentures issued in exchange and (d) in the case of a transfer, enter in the registry the name of the registered holder as directed by the transferor.
14. That subject to an agreement that the Upper-tier Municipality may enter into to the contrary, reasonable fees may be imposed by the Upper-tier Municipality for the substitution of a new Debenture or new Debentures for any of the Debentures that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized and for the replacement of any of the interest cheques that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen or destroyed. When new Debentures are issued in substitution in these circumstances the Upper-tier Municipality shall: (a) treat as cancelled and destroyed the Debentures in respect of which new Debentures will be issued in substitution; (b) certify the deemed cancellation and destruction in the registry; (c) enter in the registry particulars of the new Debentures issued in substitution; and (d) make a notation of any indemnities provided.
15. That except as otherwise expressly provided herein, any notice required to be given to a registered holder of one or more of the Debentures will be sufficiently given if it is in writing and a copy of such notice is mailed or otherwise delivered, including delivery by electronic means, to the registered address of such registered holder.
16. (1) That the Regional Chair or the Acting Regional Chair, as the case may be, and the Regional Treasurer are hereby authorized to cause the Debentures to be issued and the execution of the purchase letter in respect of the Debentures, dated October 16, 2025, by the Commissioner of Finance and Treasurer (Regional Treasurer) is hereby ratified, confirmed and approved. One or more of the Regional Treasurer and the Regional Clerk are hereby authorized to generally do all things and to execute all

other documents and papers in the name of the Upper-tier Municipality in order to carry out the sale of the Debentures through CDS's book entry only system and the Regional Treasurer or the Regional Clerk is authorized to affix the Upper-tier Municipality's municipal seal to any of such documents and papers.

(2) That the money received by the Upper-tier Municipality from the sale of the Debentures, including any premium, and any earnings derived from the investment of that money, after providing for the expenses related to their issue, if any, shall: i) in the case of such money that relates to the Capital Work of the Upper-tier Municipality described in Schedule "A" to By-law Number 2025-041, be apportioned and applied to the Capital Work described therein; and ii) in the case of such money that relates to the Capital Work of The Corporation of the Municipality of Clarington and to the Capital Work of The Corporation of the City of Pickering in the respective amount that relates to the Capital Work of each such Lower-tier Municipality described in respective Schedule "A" to By-law Number 2025-039 and By-law Number 2025-040, respectively, on the basis that each such lower-tier municipality shall apportion and apply its portion of such money to its respective Capital Work, as applicable, in accordance with this By-law, and to no other purpose except as permitted by the Act.

17. That the Upper-tier Municipality reserves the right to issue additional sinking fund debentures of the same maturity, interest rate and terms and conditions.

18. That subject to the Upper-tier Municipality's investment policy and the applicable legislation, the Upper-tier Municipality may, if not in default under the Debentures, at any time purchase any of the Debentures in the open market or by tender or by private contract at any price and on such terms and conditions (including, without limitation, the manner by which any tender offer may be communicated or accepted and the persons to whom it may be addressed) as the Upper-tier Municipality may in its discretion determine.

19. That this By-law comes into force and takes effect on the date of its final passing.

LEGAL OPINION

We have examined the Debenture By-law of the Issuer authorizing the issue of sinking fund debentures in the aggregate principal amount of \$140,000,000.00 dated October 31, 2025 and maturing on October 31, 2035.

The Debenture By-law has been properly passed and is within the legal powers of the Issuer. The four global fully registered sinking fund debenture certificates issued under the Debenture By-law in the within form (the “**Global Debentures**”) are direct, general, unsubordinated, joint and several obligations of the Issuer and of its lower-tier municipalities (the “**Lower-tier Municipalities**”). The Global Debentures are enforceable against the Issuer and the Lower-tier Municipalities subject to the special jurisdiction and powers of the Ontario Land Tribunal over defaulting municipalities under the *Municipal Affairs Act*, as amended. This opinion is subject to and incorporates all the assumptions, qualifications and limitations set out in our opinion letter delivered on the date of the Global Debentures.

CONDITIONS OF GLOBAL DEBENTURE

Form, Denomination, Ranking and Beneficial Interests in Global Debenture

1. The sinking fund debentures issued pursuant to the Debenture By-law (individually a “**Debenture**”, collectively the “**Debentures**”) are issuable as fully registered Debentures without coupons in in minimum denominations of \$1,000.00.
2. The Debentures are direct, general, unsubordinated, joint and several obligations of the Issuer and of the Lower-tier Municipalities. The Debentures rank concurrently and equally in respect of payment of principal and interest with all other debentures of the Issuer except for the availability of money in a sinking or retirement fund for a particular issue of debentures.
3. This Debenture is a Global Debenture registered in the name of the nominee of CDS and held by CDS. Beneficial interests in this Global Debenture are represented through book entry accounts, to be established and maintained by CDS, on its records for CDS’s participants (the “**Participants**”) in accordance with its participant agreement and rules and procedures which are posted on CDS’s website.
4. Except in the limited circumstances described herein, owners of beneficial interests in this Global Debenture will not be entitled to have Debentures registered in their names, will not receive or be entitled to receive physical delivery of Debentures and will not be considered registered holders of Debentures under the Conditions. The Issuer does not have any responsibility or liability for maintaining, supervising or reviewing any records of CDS or Participants relating to payments made or to be made by CDS or any Participant on account of beneficial ownership interests in this Global Debenture.

Certificated Debentures

5. This Global Debenture is exchangeable, in whole but not in part, for certificated Debentures in definitive form registered in the name of a person other than CDS or its nominee only upon the occurrence of any of the following events (a) upon 30 days notice by CDS to the Issuer, CDS may discontinue the eligibility of this Global Debenture on deposit, or cease to hold this Global Debenture in respect of the Debentures; or (b) if CDS ceases to be a recognized clearing agency under applicable Canadian or provincial securities legislation and a successor is not appointed; or (c) if the Issuer gives CDS appropriate notice that it is unable or unwilling to continue to have CDS hold this Global Debenture as a book entry only security or that it desires or has processed an entitlement requiring a withdrawal of this Global Debenture, and the Issuer has all right, power, capacity and authority to do so.
6. Debentures issued in exchange for this Global Debenture shall be issued as certificated Debentures in definitive form in authorized denominations, shall have the same benefits and be subject to the same terms and conditions as this Global Debenture (except insofar as they specifically relate to this Global Debenture as such), shall be registered in such names and in such denominations as CDS shall direct and shall be delivered as directed by the persons in whose names such definitive Debentures are to be registered.
7. Upon the exchange of certificated Debentures in definitive form for this Global Debenture, the Issuer shall receive and cancel this Global Debenture, shall reduce the holdings of CDS & CO. on the registry to nil and shall issue or cause to be

issued in exchange for this Global Debenture certificated Debentures in definitive form in an aggregate principal amount equal to and in exchange for the Participants' proportionate interests in this Global Debenture as of the record date for such exchange, as directed by CDS. On or after any such exchange, but only to the extent reasonably practicable in the circumstances, the Issuer shall make all payments in respect of such certificated Debentures in definitive form to the registered holders thereof, notwithstanding such exchange occurred after the record date for any payment and prior to such payment date.

Registration

8. The Issuer will keep at its designated office in the Region of Durham a registry in which shall be entered the names and addresses of the registered holders of Debentures and particulars of the Debentures held by them respectively and in which transfers, exchanges and substitutions of Debentures may be registered.

Title

9. The Issuer shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Issuer shall deem and treat registered holders of Debentures, including this Global Debenture, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Issuer on the Debentures to the extent of the amount or amounts so paid.

Payments of Principal and Interest

10. In each year during the currency of the Global Debentures, interest on the Global Debentures shall be payable in semi-annual instalments of \$2,625,000.00 on each of April 30 and October 31. The amount of \$6,055,471.08 shall be deposited on or before October 31 (commencing on October 31, 2026) by the Issuer into a sinking fund for the payment of the principal of the Global Debentures at maturity (the "**Sinking Fund**"), all in accordance with the provisions of the Municipal Act, 2001, as amended.
11. The record date for purposes of payment of principal and interest on the Debentures in addition to the annual deposit into the Sinking Fund is as of 5:00 p.m. on the sixteenth calendar day preceding any Payment Date, including the maturity date. Principal of and interest on the Debentures are payable by the Issuer to the persons registered as holders in the registry on the relevant record date. The Issuer shall not be required to register any transfer, exchange or substitution of Debentures during the period from any record date to the corresponding Payment Date.
12. The Issuer shall make all payments in respect of semi-annual interest on the Debentures on the Payment Dates commencing on April 30, 2026 and of principal at maturity electronically in final and irrevocable same-day funds in accordance with the applicable requirements of CDS, so long as this Global Debenture is held by CDS.
13. In the case that certificated Debentures in definitive form are issued, the Issuer shall make all payments in respect of principal and outstanding interest in lawful money of Canada at maturity upon presentation and surrender thereof at any specified branch in Canada of the Issuer's bank designated in the definitive Debentures, and prior to maturity, shall make payments of interest, by cheque sent

by mail to the registered addresses of the registered holders or, if authorized in writing, by electronic transfer.

14. Whenever it is necessary to compute any amount of interest in respect of the Debentures for a period of less than one full year, other than with respect to regular semi-annual interest payments, such interest shall be calculated on the basis of the actual number of days in the period and a year of 365 days or 366 days, if applicable.
15. Payments in respect of contributions to the Sinking Fund as well as principal of and interest on the Debentures shall be made only on a day on which banking institutions in Toronto, Ontario, are not authorized or obligated by law or executive order to be closed (a "**Business Day**"), and if any date for payment is not a Business Day, payment shall be made on the next following Business Day and no further interest shall be paid in respect of the delay in such payment.
16. Where a Debenture is registered in more than one name, the principal of and interest from time to time payable on such Debenture shall be paid to or to the order of all the joint registered holders thereof, failing written instructions to the contrary from all such joint registered holders, and such payment shall constitute a valid discharge to the Issuer.
17. In the case of the death of one or more joint registered holders, despite sections 9 and 16 of the Conditions, the principal of and interest on any Debentures registered in their names may be paid to the survivor or survivors of such holders and such payment shall constitute a valid discharge to the Issuer.

Transfers, Exchanges and Substitutions

18. Debentures are transferable or exchangeable at the office of the Regional Treasurer of the Issuer upon presentation for such purpose accompanied by an instrument of transfer or exchange in a form approved by the Issuer and which form is in accordance with the prevailing Canadian transfer legislation and practices, executed by the registered holder thereof or such holder's duly authorized attorney or legal personal representative, whereupon and upon registration of such transfer or exchange and cancellation of the Debenture or Debentures presented, a new Debenture or Debentures of an equal aggregate principal amount in any authorized denomination or denominations will be delivered as directed by the transferor, in the case of a transfer or as directed by the registered holder in the case of an exchange.
19. The Issuer shall issue and deliver Debentures in exchange for or in substitution for Debentures outstanding on the registry with the same maturity dates and of like form in the event of a mutilation, defacement, loss, mysterious or unexplainable disappearance, theft, destruction or dematerialization, provided that the applicant therefor shall have: (i) paid such costs as may have been incurred in connection therewith; (ii) (in the case of a mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized Debenture) furnished the Issuer with such evidence (including evidence as to the certificate number of the Debenture in question) and indemnity in respect thereof satisfactory to the Issuer in its discretion; and (iii) surrendered to the Issuer any mutilated or defaced Debenture in respect of which new Debentures are to be issued in substitution.
20. Each Debenture executed and delivered upon any registration of transfer or exchange for or in substitution for any Debenture or part thereof shall carry all the rights to interest, if any, accrued and unpaid which were carried by such Debenture

or part thereof and shall be so dated.

21. Subject to an agreement that the Issuer may enter into to the contrary, the Issuer shall not impose any fees in respect of the Debentures, in the normal course of business, other than reasonable fees for the issue of new Debentures in substitution for Debentures that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized, or for the issue of new cheques, in substitution for interest cheques that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen or destroyed.

Purchases

22. Subject to the investment policy of the Issuer and the applicable legislation, the Issuer may, if not in default under the Debentures, at any time purchase Debentures in the open market or by tender or by private contract at any price and on such terms and conditions (including without limitation, the manner by which any tender offer may be communicated or accepted and the persons to whom it may be addressed) as the Issuer may in its discretion determine.

Additional Debentures

23. The Issuer reserves the right to issue additional sinking fund debentures of the same maturity, interest rate and terms and conditions.

Notices

24. Except as otherwise expressly provided herein, any notice required to be given to a registered holder of one or more of the Debentures will be sufficiently given if it is in writing and a copy of such notice is mailed or otherwise delivered, including delivery by electronic means, to the registered address of such registered holder. If the Issuer or any registered holder is required to give any notice in connection with the Debentures on or before any day and that day is not a Business Day then such notice may be given on the next following Business Day.

Time

25. Unless otherwise expressly provided herein, any reference herein to a time shall be considered to be a reference to Toronto time.

Governing Law

26. The Debentures are governed by and shall be construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable in Ontario.
